## NOTIFICATION

The Executive Council in its 51<sup>st</sup> meeting held on 31.03.2017 vide Resolution No. 37 has Considered and approved the recommendations of the Committee constituted by the Vice-Chancellor for channel of promotion for various posts of non-teaching staff. Accordingly, the channel of promotion for the following Non-teaching posts will be as under:

1. **Promotion Channel for the Library Staff holding the post of Restorer/Library Attendant:**  
Restorer/Library Attendant  $\Leftrightarrow$  Junior Library Assistant  $\Leftrightarrow$  Senior Library Assistant  
*Their inter-se-seniority shall be counted from the date of their joining on the post of Restorer/Library Attendant*
2. **Promotion Channel for Drivers:**  
Driver  $\Leftrightarrow$  Transport Supervisor
3. **Promotion Channel for Group D (Class-IV) Employees:**  
Group-D (Class-IV)  $\Leftrightarrow$  Clerk-cum-DEO (under promotional quota by considering the rules of Kurukshetra University, Kurukshetra and Haryana Govt, in suppression to earlier decision of the Executive Council)  
*Their inter-se-seniority shall be counted from the date of their joining on their respective posts.*
4. **Promotion Channel for JE's and SDE's:**  
The promotion Channel for the above cadre as under by changing the mode of recruitment of the post of Executive Engineer from direct recruitment to promotional post:  
Junior Engineer  $\Leftrightarrow$  Sub Divisional Engineer  $\Leftrightarrow$  Executive Engineer  
As per the relevant rules of Kurukshetra University, 50% post of S.D.Os should be filled up by promotion, if the internal candidates hold the requisite qualification and have at least 8 years' experience in the University as Sectional Officer and also pass prescribed test as is done in the Haryana Govt.  
*Their inter-se-seniority shall be counted from the date of their joining on their respective posts.*
5. **Promotion Channel for Pharmacist:**  
Pharmacist  $\Leftrightarrow$  Chief Pharmacist
6. **Promotion Channel for Staff Nurse:**  
Staff Nurse  $\Leftrightarrow$  Nursing Sister
7. **Promotion Channel for Laboratory Technician:**  
Laboratory Technician  $\Leftrightarrow$  Senior Laboratory Technician
8. **Promotion Channel for Legal Assistant:**  
The Legal Assistant shall be considered at par with Assistant for promotion
9. **Promotion Channel for Tracer, Draftsman and Head Draftsman:**  
The promotion channel for the posts of Tracer, Draftsman and Head Draftsman will be at par with PWD, Govt. of Haryana promotion Rules.
10. **Promotion Channel for Private Secretary to Vice-Chancellor:**  
Private Secretary to Vice-Chancellor  $\Leftrightarrow$  Assistant Registrar  
The Executive Council has resolved to exclude the phrase "By treating change of Cadre" regarding promotion channel for Private Secretary.

11. Promotion Channel for Senior Technical Assistant and Computer Assistant/DEO:

Computer Assistant/DEO ⇌ Senior Technical Assistant ⇌ Junior Programmer ⇌ Programmer ⇌ System Manager

12. Promotion Channel for Accounts Clerk and Accountant:

Accounts Clerk ⇌ Accountant ⇌ Deputy Superintendent ⇌ Superintendent ⇌ Assistant Registrar

However, before considering their case for promotion, they must withdraw the C.M. No. 9094/2014 titled as Kuldeep Goyal V/s State of Haryana & ors. pending in the Hon'ble Punjab & Haryana High Court as undertaken by them in their representation and the relief claimed by them in the petition is covered in the above proposed channel.

13. Promotion Channel for Steno's:

The Steno-typist shall be considered for promotion to the post of Assistant subject to their submission of option in this regard and withdrawal of legal proceedings filed, if any by any of the Steno-typist as the same becomes infructuous by granting them the above channel of promotion as prayed.

The above said promotional channel of non-teaching posts may be read with the recommendations of the Committee constituted by the Vice-Chancellor for the purpose to avoid any inconsistency.
