Subject: Grant of reservation to persons with disabilities in Jobs under Government/ Government Undertakings, Local Bodies and Universities etc.

Sir/Madam,

I am directed to invite your kind attention to the Government instructions issued vide letter of even number dated 15.07.2014, in which it was decided to provide 3% horizontal reservation to persons with disabilities in case of direct recruitment to Group C and D in total cadre posts and in the case of Group A and B posts reservation was to be provided only on identified posts (in direct recruitment quota).

2. In compliance of Hon'ble Supreme Court judgement dated 08.10.2013 passed in Civil Appeal No. 9096 of 2013 and order dated 23.05.2016 passed by the Commissioner for Persons with Disabilities in Case No. 165 of 2015 and 184 of 2016, the State Government on reconsideration of the matter has now decided that three (03) percent posts in case of direct recruitment for Group A, B, C and D shall be horizontally reserved for persons with disabilities on the total number of posts in the cadre strength and also in the case of promotion to Group A, B, C and D w.e.f. date of PWD Act coming into force on the posts identified for persons with disabilities notified by the Ministry of Social Justice & Empowerment (Department of Disability Affairs) Government of India, New Delhi from time to time and vide their Notification No. 16-15/2010- DDIII, dated 29<sup>th</sup> July, 2013 adopted by the Haryana Government Social Justice & Empowerment Department vide their notification dated 27.1.2017 issued vide Endst. No. 130-SW(4) 2017, dated 3.2.2017.

The above instructions may please be brought to the notice of all concerned for strict compliance.
