The committee discussed the request received from the Principal, Govt. National College, Sirsa and requests of students regarding admission in Regular Mode from Distance Mode and recommended the following modifications in the existing Instructions/Guidelines for the session 2012-13:

1. While preparing merit list for admission in B. Sc.(Non-Medical/Medical) courses, Physics, Chemistry, Mathematics/Biology subjects will be considered along with English subject. This paragraph be added at the end of para No. 2 of Point No. 3, page No.5, (Recognition of Examination).
2. Point No. 4 of Note in Appendix A (Weightage(s)) page No, 16 be deleted as the point is contradictory to the Clause (C) in the Appendix-A.
3. Those students who are enrolled in a particular course under Distance Education Mode, cannot be allowed to switch to Regular Mode of that course.
4. The second and third schedule for late admissions in UG Courses of affiliated colleges of this University is as under:

2nd Schedule: last date for receipt of application form: 27.07.2012 up to 5.00 p.m.
Physical Presence : 30.07.2012 upto 11.00 a.m. sharp
Fee deposit : 30.07.2012 upto 5.00 p.m.

3rd Schedule: First come first basis with late fee @ Rs. 100/- per day up to 31.08.2012 where the waiting list does not exist.
