Requisition Order under section 160 of the Representation of the People Act, 1951 for Premises required in connection with General Elections

Whereas, it has been made aware to the District Magistrate that the premises of all Government and Private Buildings of District Sirsa are required in connection with conduct of General Elections to the Lok Sabha for the purpose of being used as Polling Stations in all Assembly Constituencies falling in District Sirsa.

AND whereas, it is necessary in connection therewith to make an order of requisition and such further orders as may appear to be necessary to expedient in connection with the requisitioning.

Now, therefore, in exercise of powers conferred upon me under Section 160 read with Section 166 of the Representation of the People Act, 1951 and the Haryana Government, Home Department notification No. Elect-67-948 dated 13.02.1967, I. R. K. Singh, IAS, District Magistrate, Sirsa, do hereby requisition the premises of all Private/Community Buildings w.e.f. 24.05.2024 till polling process is over and direct the custodian or person in possession of the said premises to whom it is addressed to be served on him in the manner prescribed by Rule 98 of the Conduct of Election Rules, 1960 to deliver possession of the same to the Assistant Returning Officers of all Five Assembly Constituencies as and when demanded by him during the aforesaid period.


