
THE TORCH BEARER (25th September, 1914 – 6th April 2001)

UNIVERSITY AT A GLANCE

Established on 2nd April, 2003, CDLU, Sirsa is named after Jan Nayak Chaudhary Devi Lal, the former Deputy Prime Minister of India and the former Chief Minister of Haryana. This University, set up by the Government of Haryana under Act 9 of 2003 passed by the State Legislature, has a sprawling campus of 213 Acre, 4 Kanal, 12 Marla at Barnala Road, Sirsa.

The university has four Teaching Blocks, well-equipped labs, Vivekananda Library, five well-furnished hostels for boys and girls, Media Centre with a Community Radio Station, a majestic Multi Purpose Hall and auditorium, Shopping Complex, University Health Centre and the branch of a nationalized bank, Guest House, Vice Chancellor's residence and 144 houses for the teaching and non-teaching staff. Fifth teaching block is near completion, besides extension of other buildings.

The main objective of the University is to facilitate, promote and excel in Higher Education, Research and Consultancy in the conventional as well as emerging areas of knowledge. To enhance the standard of higher education and increase the research activities the University has been connected to National Knowledge Network (NKN) provided through one GBPS (optical fiber) dedicated line under NMEICT project of Ministry of HRD India. Wi-Fi facility has also been provided in the University campus. During the lock down and in the post lock down period the university has adopted online mode of teaching. The process of admission is also online and to ensure the health hazards of the prospective students, the admission process has been simplified and it is expected that the students will be self-accountable in furnishing the relevant information and will enter into academic programmes in full earnestness and with integrity for self-enrichment.

The university at present has (approx.) **62** colleges affiliated to it. The total enrollment of students in UTDs, University College and Affiliated Colleges crosses 42000.

30 Teaching Departments in the University offers 43 academic programmes under budgeted mode and Self Financing System and University School for Graduate Studies offers 13 programmes as per NEP-2020 in the area of Technology, Management, Commerce, Law, Journalism and Mass Communication, Humanities, Social Sciences, Science and Education. Well-known, reputed and experienced academicians and professionals have been associated in preparing the academic curriculum of different programmes as per the guidelines of the UGC and other regulatory bodies. Teachers of the university have wide national and international exposure.

The emphasis is to impart quality education by providing congenial and liberal atmosphere in the campus through the promotion of extracurricular activities. Sports events at university, state, North Zone and All India Intervarsity level are organized. Students also participate in Youth Festivals at University, State, North Zone and All India level. NSS and Red Cross etc. provide scope for extension activities. Thus the university prioritizes to enable students achieve overall growth of their personality as professionals and humans.

University Vivekananda Library is well stocked with more than 1 lac quality books and journals. Students can access e-books and e-journals through REFREAD through online resources. The reading rooms in the University Library are open for students to study during night under normal conditions.

The University has adopted innovative methods in conducting University examinations. The students of this University have shown commendable results in academics as well as co-curricular activities. With the present pace of progress already acquired, the University looks forward to having a promising future.

The university has signed MOUs with foreign governments/educational institutions in accordance with the national drive for the internationalization of Indian higher education. The mission is to inculcate productive quality among the students who will strive for the upliftment of humanity at large.

UNIVERSITY SCHOOL FOR GRADUATE STUDIES (USGS)

National Education Policy (NEP) -2020 has provided an impetus to the changing horizons of Higher Education. The University has established University School for Graduate Studies (USGS) in Teaching Block-IV (Dr. APJ Abdul Kalam Bhawan) in order to start new programmes for tuning ourselves to the latest state-of-the-art in Higher Education. USGS will focus on Four Year Degree Programmes (FYDP) to strengthen the graduate studies especially on designing, developing, execution of market and industry oriented demand. To benefit students, society and faculty, the USGS is destined to start undergraduate programmes based on Learning Outcomes Curriculum Framework and as per NEP-2020 such as: (i) B.Sc. Physics (ii) B.Sc. Mathematics (iii) B.Sc. Data Science (iv)B. C. A. (v)B. Sc. Food Science & Technology (vi) B. Sc. Fashion Design & Lifestyle Technology (vii) B. Sc. Physical, Health and Sports Education (viii) B. Com. (ix) B.B.A (x) B. A. Journalism and Mass Communication (xi) B. A. Economics & Finance (xii) Bachelor of Social Work (xiii) BPA-Theatre.

The holistic development of the students to compete the changing scenario of the world in the 21st century is of prime importance. USGS is committed to impart quality education comprising academic knowledge and technical skills to the students.

DEPARTMENT OF LAW

The Department of Law was established in 2000 erstwhile of the P.G. Regional Centre of Kurukshetra University, Kurukshetra. The Department is having four programmes namely LL.B. Three Years (Professional) Programme, B.A., LL.B. Five Years (Integrated) Programme, LL.M. Two Years Programme and Ph.D Programme. The Department aims to disseminate legal knowledge to empower people at all levels. The department offers opportunity pathways that attract students with a diverse range of interests and backgrounds and prepare graduates for extra ordinary careers. The Department aspires to promote ethical practice in the legal profession so as to enable fairness and sense of responsibility in legislation, decision making and advocacy. The Department is having separate building only for law students namely Dr. Ambedkar Bhawan (Teaching Block 3). Separate air conditioned library with E-journals, moot court hall, separate common rooms for boys and girls, smart class room, lecture theatres are the features of the department building. The department is having experienced faculty in law and pre law subjects. The Department of Law prepares lawyers leaders to serve the community through meticulously designed legal education, experiential training and professional identity formation with in an inclusive environment.

UNIVERSITY CENTRE FOR OUTREACH PROGRAMS AND EXTENSION (UCOPE)

Ambitious Metamorphosis of the University can be achieved by way of establishing a couple of Special Purpose Vehicles (SPVs); one of them is the University Centre for Outreach Programs and Extension (UCOPE) which has been recently established in Teaching Block-IV (Dr. APJ Abdul Kalam Bhawan) of the university.

The COPE envisions to use education and technology for:

- Inculcating basic skills among students;
- Facilitating avenues for training and placement of the students;
- Conducting Outreach and Extension programmes by undertaking training and consultancy services;
- Setting up Centres for focus areas like Gender Studies, Rural Development etc. and Chairs in the name of Celebrated leaders.
- All activities that have hitherto called extracurricular and co-curricular, the academic aspects of such activities will be managed by UCOPE.

The Centre will fill up the gap of skill enrichment and university extension and outreach endowment as envisaged in NEP-2020.

CENTRE FOR RURAL STUDIES (CRS)

Chaudhary Devi Lal University Sirsa is located in the rural hinterland and therefore considered to be educationally backward. The economic life of the university's catchment area in the Sirsa and Fatehabad districts (the colleges of these districts are affiliated to this University) of Haryana state, Bhatinda, Mansa and Barnala districts of Punjab state and Hanumangarh and Sri Ganga Nagar districts of Rajasthan primarily dependents upon on agriculture activities. The rural demographic character of the University necessitates conducting and promoting studies in rural affairs. Thus, the rationale for setting up the Centre for Rural Studies. The Centre will be headed by a Director (equivalent to the rank of Professor and should have experience of rural affairs related research studies) with adequate staff and own office. The UCRS will:

- a) Prepare, develop and deliver academic programs focusing on rural affairs.
- b) Promote research in rural affairs.
- c) Institute award for excellent research work in rural affairs.
- d) Conduct training programs for elected representatives of PRIs and officials engaged in delivering services to rural people or engaged in rural development.

COLLEGE BRANCH

At present 62 affiliated colleges are running with CDLU, Sirsa. Total Colleges = 62, Degree Colleges = 29 Education Colleges = 28, Law College = 01, Sanskrit College = 01, Engineering Colleges = 02, Management College = 01

VIVEKANANDA LIBRARY

Vivekananda Library came into existence in the year 2003. At present, it has an impressive four storey building. The present building of library is easily approachable. Beautiful lawns, add to its grandeur. Special attention is given to the facilities of drinking water, light system and security system. Fully Air Conditioned 3 Reading Halls (24x7) and 3 Reading Halls with stack area, Computer Lab, Periodical Section and Thesis Section for Ph.D. Scholars. All the reading areas of the Library are spacious, peaceful and well furnished with comfortable furniture. The Library is having rich collection of publications which include books, journals, thesis/dissertations, reports, newspapers and magazines etc.

The Library at present has a total collection of 1,13,449 books, lots of e-Journals are available through REFREAD, 895 Thesis and Dissertation, 2131 Reference books, 550 books in regional languages, 560 books for competitive examination, 270 old question paper set in paper bank, 8 Magazines, 1 Discovery Science Magazine and 15 newspapers to cater to the needs of the users. The Library also provides Reference Books including Encyclopedia, Dictionary etc. The SC/ST Book Bank with collection of 2837 books exists in the library for SC/ST students of various departments. The facility of online Journals and database is being provided to the users by INFLIBNET through UGC Infonet Digital Library Consortium Shodh Sindhu. Inter Library Loan facility is also available through DELNET. The Wi-Fi internet connectivity is available in the Library for easy access of internet services. Further, there is an access to E-books within University campus. The concept of fully automation of Library is adopted by the Vivekananda Library.

HOSTELS

At Present, there are five hostels-three for girls and two for boys, namely, Harki Devi Bhawan (Girls' Hostel-I), Kalpana Chawla Bhawan (Girls' Hostel-II), Savitri Bai Phulle Bhawan (Girls' Hostel-III), Lala Lajpat Rai Bhawan (Boys' Hostel-I) and Sardar Patel Bhawan (Boys' Hostel-II with extension). All the five hostels have been provided with tube/LED lights and ceiling fans in every room. Solar panels are also installed at roof top of all these hostels. Electric geysers have been installed in bathrooms. Water coolers with RO system have also been provided. The hostels subscribe several national and regional magazines and newspapers for enabling the students to know what is happening around the world. The facility of LED has been provided in common rooms of all the hostels. Full A.C. reading hall is available for all girls in Girls Hostel-III and for boys Hostel-II. Medical facilities to all hostel residents are provided through the university Health Centre located in University premises. Washing machine facility is also available in all the Hostels. Besides, one ANM and Ambulance facility has also been provided for the girl residents.

The Chief Warden, along with all Wardens, makes every possible effort to see that the students get a cleaner

surrounding within and outside the hostel premises, get hygienic food and always respond to the complaints of hostel residents in a positive manner. A total number of 38 benches (Three-seater each) have been provided in the premises of Girl's and Boy's Hostels separately. In the premises of both Girls Hostels, two separate lawns have been developed and Badminton Courts has also been constructed in four hostels. In Girl's Hostels, the facility of Table Tennis & Badminton and in Boy's Hostels, the facility of Table Tennis, Badminton and Volleyball has also been provided. The Gymnasium facility has been provided in the Hostels. E-rickshaw facility has also been provided for the residents of the hostels.

UNIVERSITY IT & DATA CENTRE

IT Facilities and Infrastructure:

1. Internet Connectivity (Lease Lines)

The University has procured the following two (02) different dedicated Internet Lease Lines for uninterrupted and 24 x 7 Internet access for its stakeholders:

- i) Dedicated Lease Line (1:1) provided by National Knowledge Network (NKN) with **1 GBPS** bandwidth since 2011.
- ii) Dedicated Lease Line (1:1) procured by the University with **700 Mbps** bandwidth from Railtel Corporation of India for 3 years.

2. Networking

UITDC has established a University-wide Local Area Network (LAN) and W-LAN/Wi-Fi for providing internet facilities to all stakeholders. An optical Fiber-based LAN setup has approximately 400 nodes. Wi-Fi connectivity is available 24x7 in all buildings with 411 Access Points.

The University has Data Centre/Server Room with high-end and latest configuration servers with uninterrupted power supply for various IT projects like the Examination System, Online Admissions, University Website, Digital Library etc.

UITDC prefers the latest and next-generation IT tools and gadgets such as firewalls, L-3/L-2 switches, managed switches, routers, bridges, log servers, etc. for upgrading the existing IT infrastructure.

3. Internet Access

The university has recently upgraded the firewalls by procuring Hardware-based Next-Generation Firewalls to provide a safe, secure, and restricted internet browsing environment. UITDC is providing two-tier authentication to all internet users of the University to avoid unauthorized access and misuse of the internet. Each internet user has a unique user ID and password for using internet services in the campus of the University.

4. Webmail Services

University has subscribed to Google Workspace for Education Fundamentals for facilitating its stakeholders for smooth functioning of teaching-learning processes, online meetings, webmail services for official correspondence, and free data storage/cloud service to store important files, documents, etc

University Computer Centre: Two Computer Labs (UCC) having 91 Nos. of desktop computers with LAN & Wi-Fi connectivity, adequate furniture and sufficient power backup, have been established on the 2nd floor of Vivekananda Library to facilitate the students, research scholars, and staff members (teaching & non-teaching) as per their requirements. In addition to above, three (3) Computer Labs having 107 Nos. of desktop computers with LAN & Wi-Fi connectivity, adequate furniture and sufficient power backup have been established recently in the Dr. APJ Abdul Kalam Bhawan, CDLU, Sirsa.
- **7. University Website:** The University Website (www.cdlu.ac.in) is being maintained and updated efficiently, effectively and promptly by the University Website Office. Being very descriptive and informative, the number of global visitors on the University website is increasing day by day. Further, this office has initiated the process of strengthening the website accessibility.
- **8. Social Media:** The social media pages/accounts such as facebook, tweeter, LinkedIn have been created for sharing the required day-to-day activities & important information and linked with University Website at the Home page tab "follow us".
- **9. Online Admission:** The process of Online Admission under various programmes run by the University Teaching Departments (UTDs) and USGS for the Session 2024-25 of the University has been started.

Results Branch

Results Branch is an important Branch of Examinations Wing and working under the control & supervision of Controller of Examinations. The result processing (Pre & Post Examinations) has been switched over to digital platform. The admit card are also issued electronically. All results are also processed digitally. To upgrade examination work including result of the students, an MoU, has been signed with NCCF for preparation of in-house customized softwares for pre and post examinations. Every year thousands of students of various affiliated Degree Colleges, Engg. Colleges, Management Institute, Education Colleges, University School for Graduate Study and University Teaching Departments are dealt with by the Results Branch. The prime objective of the Result Branch is to provide timely declaration of results, DMCs and Degrees. The results and other details of individual students are made available online by providing individual login ID and password to each and every student. Further, the National Academic Depository (NAD) of UGC has also been implemented for the benefit of the students so that the students may access his/her Degrees/DMCs digitally anytime anywhere. The Learning Outcomes based Curriculum Framework (LOCF) for Post Graduate Programmes has also been implemented for the students of the University. Recently, UGC has introduced Academic Bank of Credits (ABC) Scheme. The University has also been implemented the same so that the students can use their earned credits of study in future.

SC/ST CELL

The SC/ST Cell has been established to provide facilities to the SC/ST students of the University as per the instructions of UGC/State Govt. from time to time. SC/ST Cell functions as grievances Redressal Cell to redress the grievances of SC/ST Students and Employees of the university, and renders them necessary help in solving their academic as well as administrative problems. It also carries out any other work assigned from time to time so as to promote higher education among these communities, suffering from economic, social and education deprivations.

The main objective of the SC/ST Cell is to ensure proper implementation of various schemes of University Grants Commission/Govt. of India/State Govt. introduced from time to time in the interest of such students.

THE UGC CELL FOR COACHING SCHEMES FOR SC, ST, OBC (NON-CREAMY LAYER) AND MINORITIES

The University had established the UGC Cell for Coaching Schemes for SCs, STs, OBCs (Non Creamy Layer) and Minorities. General candidates holding BPL Cards (Below Poverty Line). The Cell implemented the following coaching schemes:-

- 1. Remedial Coaching
- 2. Coaching for Entry into Services
- 3. Coaching for NET/SET

Now the university is continuing this project on its own concentrating on the third of the above three objectives.

WELFARE SCHEMES FOR SC/DSC/BC STUDENTS

The University ensures proper implementation of various schemes of the UGC/Government of India/State Government concerning admission, scholarship etc. for the welfare of the students of reserved categories. The guidelines as revised from time to time by the Central and State Governments are displayed on the Notice Boards, prominent places and in the University prospectus for the benefit of the students belonging to SC/DSC/BC category. The guidelines are strictly adhered to. Apart from Post-Matric Scholarship for SC/DSC/BC students, the State Merit Scholarship for students with Physical Disabilities are also offered.

CAREER AND COUNSELING CELL

A Career and Counseling Cell has been established in the University to address the diverse socio-economic handicaps, linguistic differences and geographic backgrounds of the heterogeneous population of students coming to the University vis-à-vis equity of access and placement opportunities through availability of appropriate institutional support information. The Career and Counseling Cell also helps the students by providing appropriate guidance to establish linkages with the world of work and locate career opportunities. This cell is actively involved in carrying out vocational guidance and campus based interviews. The following are the major objectives of the cell:

- To gather information on job avenues and placements in different institutions and concerns related to the Programme(s) offered by this University.
- To analyze information in the local, regional and national contexts to explore its relevance and utility for the students in their placements and on job-training.
- To organize Seminars and Guidance Workshops for informing the students about the emerging Professional Trends and Events, job profiles, leadership roles, entrepreneurship, market needs and risks and implementation of national socio-economic policies and to impart training in soft skills.
- To promote discipline, healthy outlook and positive attitudes for strengthening National Integration and removal of narrow provincial preferences and prejudice.

UNIVERSITY SCIENCE INSTRUMENTATION CENTRE

Recently, University Science Instrumentation Centre (USIC) has been established in CV Raman Bhawan (Science Block) of the University. It will work as Central Instrumentation Lab with necessary and sufficient sophisticated equipments of scientific importance within the reach of faculty members as well as research scholars for research activities. In addition, it will provide service for the maintenance of scientific instruments as far as possible.

INTERNAL QUALITY ASSURANCE CELL (IQAC)

The University has constituted the Internal Quality Assurance Cell (IQAC) to instil the momentum of quality consciousness and continuous assessment and improvement. The cell works to develop a quality system of conscious, consistent and catalytically programmed action for improving the academic and administrative performance of the HEIs and to promote measures for institutional functioning towards quality enhancement through internalization of quality culture and institutionalization of best practices. The IQAC achieved the above said goals by offering itself the National Assessment and Accreditation Council (NAAC) for inspection. Grade from NAAC is considered Hall Mark of the quality of any HEI. The University has been Accredited with Grade "B" valid for a period of five years.

STUDENTS' WELFARE

This office is actively involved in issuing bus passes to the daily passenger students and organizes the events like:

- 1. Awareness Campaign on HIV/AIDS.
- 2. Health Awareness/Checkup Camp.
- 3. Educational and Industrial Tours to different places.
- 4. Helps the University Teaching Departments students to participate in Inter College tournaments and Inter University tournaments in various games.
- 5. Assists in procurement of Yearly Group Insurance Scheme of regular students of the University Teaching Departments.
- 6. Organizes the Annual International Yoga Day on 21 st June.

- 7. Arranges Students' Induction Programme/ Orientation Programme.
- 8. Organizes Annual Athletic Meet.
- 9. The facilities of E-Riksha for students etc.

DIRECTORATE OF YOUTH WELFARE

It's impressive to see the comprehensive approach taken by the Directorate of Youth Welfare Department at Chaudhary Devi Lal University towards nurturing cultural awareness and promoting values among students. SPORTS COUNCIL

Sports activities of the University are being run under the Sports Council. The University has following playfields: Handball (1), Football (1), Volleyball (2), Netball (1), Korfball (1), Kho-Kho (1), Kabaddi (1), Wrestling (1), Basketball (2), Judo (1), Athletics Track & Multipurpose Hall for indoor sports activities and Gym (female & male).

UNIVERSITY HEALTH CENTRE

The University Health Centre located in the Shopping Complex on the 1st floor from room no. 101-104. It has sufficient place for OPD, dispensary and inward. It has facility of consultation, medicines & laboratory tests, treatment at free of cost. There is an Ambulance to carry the sick students to referral hospitals. The Health Centre provides its services during games, physical efficiency tests and functions organized by university. The students, the employees of the university and their dependents are availing the medical facilities being provided by the University Health Centre.

YOUTH RED CROSS

Youth are the pillars and future leaders of the country. Today's youth is tomorrow's India. The Youth Red Cross, the youngest wing of Indian Red Cross Society, Haryana State Branch is active at the University Level. A Youth Red Cross Unit is working in the University Campus for this purpose. A fifteen member YRC Committee of CDLU, Sirsa has been constituted under the chairmanship of the Vice-Chancellor to promote the YRC activities in all the colleges/institutions within the jurisdiction of the university. Meeting of Executive Committee at University Level and of students volunteers are called from time to time to decide about the YRC future plans.

RESEARCH & DEVELOPMENT CELL

University has a functioning office of Dean Research which acts as a pivot entity to streamline and coordinate

research related activities. Of lately, the office of Dean Research has been restructured keeping in line with University Grants Commission circulars in this regard. Accordingly, a Research & Development Cell has been established in the University which comprises six different bodies. The Cell is guided by its apex body namely Research Advisory Council which lays down the goals of the Cell. Five other committees namely Finance and Infrastructure Committee, Research Programme and Policy Development Committee, Collaboration and Community Committee, Product Development and Commercialization Committee, and IPR, Legal and Ethical Matters Committees have also been constituted to achieve the goals set by the Advisory Council. Cell is headed by the Dean Research and coordinated by Coordinator, R&D Cell

RTI CELL

The RTI Cell deals with RTI applications and RTI appeals on behalf of the University under the provision of the RTI Act and provides information to the information seekers.

ANTI RAGGING COMMITTEE

Anti-Ragging Committee supported by Anti Ragging Squad and a Nodal Officer ensures that there are no incidences of Ragging, bullying and baiting of new students on the campus. Ragging is a criminal offence and is strictly prohibited in the University. A student, if affected, can approach the Nodal Officer to redress his complaint. The Committee comprises Proctor, Dean Student's Welfare, Chief Wardens, Director Youth Welfare, Assistant Dean Students' Welfare and Hostel Wardens are also members of the Anti Ragging Committee/ Squad/Cell. The Anti Ragging Committee also has some outside members prominent along whom are SDM and DSP head quarter Sirsa besides some other important citizen of Sirsa.

In compliance of the 2nd Amendment in UGC Regulations, each student and every parent will submit an online undertaking in every academic year at www.antiragging.in. The student will receive an e-mail with his/her registration number. The student will forward that e-mail to the Nodal officer in his/her university/college e-mail.

The Nodal officer of the University/Colleges have to display the email address and contact number of the Nodal Officer of Anti-Ragging Committee of their university/college on their website and campus areas like Admission Centre, Departments, Library, Canteen, Hostel, and Common facilities, etc.

The student must fill up the Anti Ragging Undertaking under Reference No. generated on www.antiragging.in in the admission form.

ANTI EVE-TEASING COMMITTEE

EVE-teasing is a criminal offence. Making unwanted gestures towards girls or passing offensive comments are not only immoral acts but also subject to penal action under Indian Penal Code. Boys student are advised not to indulge in such acts. University has an Anti-Eve teasing Committee headed by the Vice-Chancellor. The Committee comprises Dean Academic Affairs, Proctor, Chief Warden, Dean Students Welfare, Dean of Colleges, Controller of Examination, Lady Warden, SDM Sirsa, City Magistrate, Sirsa, DSP (HQ), Sirsa, SHO (City), Sirsa besides some student representatives and important citizens are also its members.

WOMEN COMPLAINTS COMMITTEE

Women Complaints Committee for women employees and girls against sexual harassment was constituted as per University Grants Commission (Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulations, 2015.

AISHE CELL

As per directions of UGC & Ministry of Education, an online survey is conducted by HEI's on Higher Education with regards to Students details, Infrastructure, Results, Admissions, Scholarships, Fellowship, Research activities etc, every year. This University and its 62 affiliated Colleges including University College are conducting the survey accordingly so that the data of HEI's may be helpful to the Govt. for future planning/policy of higher

education etc. The AISHE unit is working under the guidance of State AISHE unit under the Directorate of Higher Education, Haryana Panchkula. It also provides online / offline training / workshop to the Nodal Officers of all affiliated Colleges from time to time.

ADMISSION PROCEDURE AND GENERAL INSTRUCTIONS FOR USGS AND DEPARTMENT OF LAW

- Candidates will have to apply for admission in ONLINE mode and they are advised to read the HBI thoroughly before filling up the Online Application Form.
- Admissions will be subject to fulfillment of the minimum eligibility conditions.
- * Warning:- Cheating and forgery are criminal offences punishable under Indian Penal Code replaced with *Bhartiya Nyaya Sanhita*, 2024, *Nagrik Suraksha Sanhita*, 2024 and *Bhartiya Sakshya Adhiniyam*, 2024. Hence, candidates must observe integrity while filling up admission form and uploading documents.
- Necessary certificates/documents/testimonials will be required at the time of admission. Application form along with photocopies of the certificates/testimonials/ documents duly self-attested should be submitted by the candidates in the concerned department before filling of the Registration Return.
- In the wake of any Pandemic, the University will follow the guidelines issued by the Government. Students seeking admission will have to abide by them.
- 1. No admission shall be allowed after **September 30th**, **2024.** It is subject to change as per Guidelines/Notification of the UGC/DHE, Haryana.
- 2. The constitution of the admission committee is as under:

i) Dean, USGS/Chairperson of the Department – Convener

ii) Incharge of the department (if appointed). — Member

iii) Two regular teachers/APC/PTT — Member

iv) One SC/ Female representative — Member

Note: The Dean/Chairperson shall include regular teachers followed by APC & PTT in the Admission Committee. Minimum three members shall form the quorum.

- 3. The merit list for admission in Four Year Undergraduate Programmes (FYUPs) will be decided on the basis of Percentage of marks in qualifying exam and weightages, if any.
- 4. All the admissions shall be provisional till their registration in the University is finalized.
- 5. To start a Programme, the requirement of minimum number of applications will be 25% of the sanctioned seats in regular programmes and 50% of the sanctioned seats in self-financing programmes. Further, the Chairperson/ Dean, USGS of concerned Department/College will ensure the financial viability before starting the Self- Financing Programme. In case the number of students admitted falls short of 10 in a particular programme, the classes for that Programme will not be started.
- 6. The University shall take decision with regard to continuity/modification/closure of the SFS Programme introduced on the basis of the assessment carried out every year. However, no Course/Programme will be called off or closed once the students have been admitted to the course on the grounds of inadequate enrolment and the resultant lack of financial viability during a particular year. The decision regarding the closure of the said course/Programme will be taken in advance, latest by closing of the academic session by the concerned Staff Council/Departmental Advisory Committee. However, to make the Programme financially viable, fee can be increased in any semester.
- 7. Candidates who, after passing one stage of education are studying in the same stage of education in a different subject e.g. Intermediate Science after Intermediate Arts or B.Com. after B.A., B.Sc. or M.A. in one subject after M.A. in other subjects will not be eligible for Post Matric scholarship.
- 8. Though a candidate can apply for admission in more than one Programme, no student shall be permitted to be on the rolls of two departments of the University or two Programmes as a regular student in the same Department or two educational institutions, simultaneously.
- 9. Admission in the same programme will not be repeated/allowed after passing the same programme.
- 10. The candidates who have passed 10+2 examination from CBSE/ICSE or any other Board with more than 5

subjects, their score of best 5 subjects including English will be taken into consideration for the purpose of determining the merit for admission to UG Programmes.

- 10. System/formula for admission:
 - (a) The candidates who come from other Universities/Institutions where percentage of marks is awarded along with CGPA, the percentage of marks as awarded by the concerned University will be considered and no further conversion is required.
 - (b) In case of other institutions or Universities where no equivalent percentage of marks is expressly provided, but the conversion formula of the CGPA awarded has been given by the concerned University/Board, the percentage of marks would be obtained by using the conversion formula of that University.
 - (c) In case of other Institutions or Universities where no equivalent percentage of marks is given or no formula for conversion of the CGPA is expressly provided, the percentage of marks will be calculated on the basis of the following formula made evident from following examples:
 - i) If a candidate gets 4 on a scale of 5, his percentage of : 4/5X100=80% marks would be
 - ii) If a candidate gets an CGPA of 7 on a scale of 10, his: 7/10X100=70% percentage of marks will be
 - iii) If a candidate gets 3 on a scale of 4, his percentage of : 3/4X100=75% marks will be.
- 11. Five percent relaxation (5 out of 100) in minimum eligibility condition for admission to various Programmes will be given to the candidates who are blind or are Differently Abled.
- 12. Unless otherwise specifically provided for a course in the concerned Ordinance, the eligibility condition for SC/ST/DSC candidates will be minimum pass marks in the qualifying examinations for admission to various Programes (as conveyed by General Administration Department, General Services III Branch, Govt. of Haryana vide their circular No. 22/129/2013 1GSIII dated 16-07-2014).
- 13. Relaxation of 5% marks in the eligibility condition will be given to SC/ST/DSC as conveyed by General Administration Department, General Services III Branch, Govt. of Haryana vide their circular No. 22/129/2013 1GSIII dated 16-07-2014 and persons with benchmark disabilities. (Annexure-II). For example:-

- 14. There will be no rounding of percentage for determining the eligibility for admission to various courses. Merit will be calculated upto two digits i.e. 67.77.
- 15. In case two or more candidates have equal percentage of marks in the merit list, their marks of the next lower examination will be considered. If again the score is equal, the candidate senior in age shall be considered first in the merit list. There shall be no rounding up percentage of marks from 0.5 and above to next higher number for determining the eligibility and merit for admission to various programmes. In case two candidates have the same merit score, the scores in the lower examinations will be considered.
- 16. The candidates shall update or submit their result/revised result of the qualifying examination at any time during the process of admission through official email of the department or send it by post but the documents must reach the concerned department at least one day before of the counseling. Their candidature will be considered for admission in subsequent provisional admission lists.
- 17. The confidential result of the qualifying examinations or the duly verified result published on the official website of the concerned University/Board shall be treated as the proof of having passed the qualifying examination in case the DMC has not been issued. In such cases, the candidate has to produce a certificate from the Principal/HOD/University concerned also showing the maximum marks of the qualifying degree. However, the candidate shall have to produce the original DMC/Degree for the purpose of admission within a month from the date of dispatch by the concerned University/Board/ or before the filing of the registration return, whichever is earlier, otherwise his/her case of registration will not be considered (to be

- sent through email or by post).
- 18. The Dean, USGS and Chairperson, Department of Law is permitted to admit the students after a gap of studies, if, the student is otherwise, eligible and his/her case falls under the admission policy. Gap year(s) affidavit shall be uploaded at the time of admission.
- 19. The provisional admission lists in descending order of merit will be displayed on the University Website or Portal as per the given schedule. No separate intimation for counseling will be sent to the candidates. For any change or revision in the schedule or vacancy of seats, the students are desired to visit the website frequently.
- 20. The students will have to upload documents at the time of admission along with application form except the migration certificate, which can be submitted for the purpose of Registration as per the schedule given in HBI in the Chapter- Registration.
 - (a) At the time of admission, every candidate shall be required to give an undertaking of good behavior as character certificate. If a candidate, after his/her admission to any programme in the USGS, is found to be indulging in any kind of ragging or any act of indiscipline, his/her admission is liable to be cancelled.
 - (b) The parents/guardian of the candidate will have to sign an undertaking to this effect to be sent through email to the concerned department. If a candidate is found to have been involved in such an act, his/her admission shall be cancelled, besides a penal action under the law will be taken against such student(s). The candidate and his/her parent/guardian shall sign an undertaking to this effect on the proforma given in HBI (Annexure-III).
- 21. Character Certificate is essential. The candidates will upload it at the time of admission.

A. Private Candidates:

Candidates who have passed the qualifying examination as private candidates should submit their character certificate duly signed by a First Class Magistrate/Public Notary/Gazetted Officer/MC of the concerned area/Sarpanch of concerned Village.

B. Candidates who have passed the qualifying examination as regular students:

Such candidates must submit the Character Certificate from the Head of the Institution last attended.

- 22. If the concerned authorities are not satisfied with the character, past behavior and antecedents of a candidate, they may refuse to admit him/her to any programme in order to ensure and maintain the academic standard, discipline and peaceful atmosphere in the University. The Vice-Chancellor may also cancel the admission of any student for a specific period on the specific complaint of Proctor/Dean, USGS.
- 23. The Admission Committee can demand to see the original certificates at any time. During the counseling period, the candidates are advised to remain alert for any message from the department in this regard.
- 24. The students enrolled in programmes other than weekend and evening programmes shall submit an undertaking to the effect that they are neither doing nor will they do any kind of job during the period of their study.
- 25. All certificates/undertakings/Self-Certifications to be submitted by the candidates should be strictly according to the format given in this Hand Book of Information.
- 26. Reservation of seats shall be as per University rules mentioned in the Handbook of Information.

27. Maternity Leave for Women Students:

The maternity leave will be granted to the students (USGS/UTDs and affiliated colleges) upto three months and attendance may be counted excluding this period in all Courses except the Courses in Law Department (where BCI rules are implemented) and the courses being run under the Department of Physical Education.

- 28. It may be ensured that the children of single parent are not denied admission in the Department/USGS on the plea that names of both the parents are not mentioned in the certificate of qualifying examination/admission form, if they are otherwise eligible/ subject to fulfillment of all other conditions of admission.
- 29. Admission Committee of the departments, in case of doubt regarding the recognition of lower qualifying examination passed by the candidate from other Institution/Board and his percentage of marks in the qualifying examinations, prior clarification must be sought from the Deputy Registrar (Academic) of this University before allowing provisional admission. An updated photocopy of Book of Equivalence of (Indian/Foreign) Examination of Kurukshetra University, Kurukshetra is available in the Academic Branch, CDLU, Sirsa. Book of Equivalence of (Indian/Foreign) Examination of Kurukshetra University,

Kurukshetra will be followed.

- 30. Those students who are enrolled in a particular Course under Distance Education mode, are not allowed to switch to regular mode of that course.
- 31. Admission Committee will be responsible for the admission and check the eligibility of the candidates.
- 32. ITI passed out candidates will be considered for admission as per letter no. Memo no. 18/23/2020 UNP (4) dated 19.02.2020 (Annexure-IV)
- 33. This University will follow the rules regarding admissions under Sports Quota in the Programmes running in the UTD's as per the Instructions Guidelines issued by the Association of Indian University.
- 34. The affiliated Colleges of the University shall follow the rules regarding admissions under Sports Quota as per the Instruction/ Guidelines issued by the State Govt.
- Two additional supernumerary seats in the PG programmes and five additional seats in TDS (UG Programmes) as over and above the sanctioned seats will be allowed to the outstanding sports persons in each program. However, the candidate shall be required to submit the grading certificate to that effect form the Director of Sports of the concerned State. The District Sports Officer/Head of the Institution shall countersign these certificates. The certificates issued by the State University of Haryana will be verified by the Secretary, Sports Council of their respective University, hence they do not need gradation certificate. This University will follow the Instructions and Guidelines of the Kurukshetra University, Kurukshetra (Annexure-V) regarding admissions under Sports Quota excepts point no. (viii) which is substituted by the provision that in case of admission in the University Teaching Departments the following committee shall resolve the dispute, if any.
 - i) Dean of Concerned Faculty
 - ii) Dean of Education/Chairperson, Department of Physical Education
 - iii) Head of the Department concerned

In case of admissions in the Affiliated Colleges, the Principal of the concerned college will be competent authority to resolve the dispute in admissions under Sports Quota.

- 36. After completion of Physical Efficiency Test (PET), the Chairperson, Dept. of Physical Education will send the list of PET qualified candidates to the UITDC at admissionhelpdesk@cdlu.ac.in.
- 37. If any student is found indulged in causing any loss to life, property or staff of the University, he/she will be prosecuted as per Proctorial Rules.
- 38. Hostel facility will not be provided to the students enrolled in any Diploma/Certificate programme.

KASHMIRI MIGRANTS

The following concessions are admissible for the wards of Kashmiri Migrants for admission during academic session 2024-25:

- i. Relaxation in cutoff percentage up to 10% subject to minimum eligibility requirement.
- ii. Increase in intake capacity up to 5%- Programme (s) wise.
- iii. Reservation of at least one seat in merit quota in technical/professional institutions.
- iv. Waiving off domicile requirements for Kashmiri Migrants only. Kashmiri Pandits /Kashmiri Hindu Families (Non-Migrants) living in the Kashmiri Valley need domicile certificate.

SUPERNUMERARY SEATS

- 1. Two supernumerary seats will be created as a part of the Special Scholarship Scheme for Jammu & Kashmir for students from Jammu & Kashmir.
- 2. One additional seat shall be for NCC candidate who attended the Republic Day Parade & Camp in all Programmes over and above the sanctioned seats.
- 3. One additional seat shall be for NSS merit certificate holder who attended the Republic Day Parade Camp in all the Programmes over and above the sanctioned seats.
- 4. One additional seat in each Programme shall be for deserving Parsi Students.
- 5. One additional seat in each Programme shall be for the children who have lost both their parents during the COVID pandemic. If, he/she produce the certificate under PM CARES for children

- scheme 2021 issued by the Ministry of Women and Child Development.
- 6. Seats in each programme of UTDs and USGS shall be provided to the Orphan children (one for male and one for female in) from Sirsa and Fatehabad Districts except NCTE, BCI and PCI etc. courses. The fees, books and hostel facility will be provided to such students.

Rules regarding admission of foreign nationals

- 1. Upto 25% supernumerary seats are allocated for all the programs running in the University Campus.
- 2. The admission of foreign students in UG/PG program are hereby offered for the courses running in the Campus of CDLU, Sirsa for the Academic Session 2024-25.
- 3. The decisions would be applicable to all foreign nationals who apply for admission in UG/PG program in the CDLU, Sirsa.
- 4. Only the foreign students having a foreign passport and wards of Indians working in the Gulf countries shall be eligible to apply for admission to a particular course.
- 5. The applicants applying under this category need not appear for the entrance examination conducted for the purpose. The eligibility conditions for the foreign nationals would remain the same as for the Indian Nationals as per HBI of this University. The admissions would be given based on a merit list prepared on the basis of marks obtained in the qualifying exam, other terms and conditions remaining same as that for Indian nationals. In case the University/Board is not included in the AIU list, the foreign student must obtain and submit Equivalence Certificate to this effect from the Association of Indian Universities. The link of AIU for this purpose is https://evaluation.aiu.ac.in/Student/Login
- 6. The medium of instructions would be English except in the subject of languages and it is presumed that any foreign student seeking admission in any language specific course has a prior knowledge of the language.
- 7. The foreign students admitted to UG/PG program will be charged fee as under:
 - (i) For Science subjects USD 425 in equivalent INR currency per semester (for UG programs)
 - (ii) Other than Science USD 325 in equivalent INR currency per semester (for UG programs)
 - (iii) For Science subjects USD 525 in equivalent INR currency per semester (for PG programs)
 - (iv) Other than Science USD 425 in equivalent INR currency per semester (for PG programs)

Note: - The payment made in INR would be the conversion of rate (buying rate) of that date as per RBI regulation in this regard.

8. Other General Guidelines:

- (i) The guidelines would be applicable to all foreign nationals who apply for admission in UG/PG program in the CDLU, Sirsa.
- (ii) The course on which eligibility is relied upon must be included in the list of the Association of Indian Universities (AIU).
- (iii) The attestation of all documents essentially required to be done by the concerned Embassy/High Commission/Consulate of the relevant country in India. The documents without attestation shall be summarily rejected.
- (iv) The foreign nationals/students applying from their own country should get their transcripts of certificates attested by the concerned accredited authorized Government agency and also duly certified by the Indian Embassy or Consulate as the case may be.
- (v) English translation of transcripts of certificates duly attested should be provided/supplied wherever necessary.
- (vi) A character certificate from the head of the institution last attended is mandatory for admission in UG/PG program.
- (vii) Foreign students admitted to UG/PG program at CDLU Sirsa are required to obtain long term STUDENT VISA in the name of CDLU, Sirsa on the basis of admission within 45 days from the date of admission and submit it in the office of Dean, IR/FA, CDLU Sirsa. In case the student fails to do so, the University reserves the right to cancel admission and in such situation, the admitted student can make a claim for refunding his/her fee which will be refunded but after deducting 100 US dollars as the admission processing fee. The Vice Chancellor can condone the delay in submitting or procuring visa or any other documents required for continuing admission.
- (viii) Following documents shall be submitted by the admitted students to the office of Dean, International Students' for police registration in Police Station within 14 days of his/her arrival: Attested photocopy of passport, visa, proof of residence, proof of admission and four passport size photographs and other such documents required by the office of the Dean IR/FA.

- (ix) If the scholar is found to be indulging in any illegal activity, his/her admission would stand cancelled immediately.
- 9. All foreign nationals seeking admission to the University will be required to produce a medical certificate of fitness from a recognized hospital in their country. Those admitted may also be required to undergo a comprehensive medical examination (HIV, AIDS etc.) within a week from the date of the admission.
- 10. The final authority for interpreting the rules and guidelines given herein, or condonement of any nature, would rest with the Vice Chancellor.
- 11. In case of any dispute related to these terms and conditions and otherwise, the matter shall be subjected to the jurisdiction of the Civil Court, Sirsa, Haryana.
- 12. UGC guidelines for admission & creation of supernumerary seats of International students in UG & PG circulated vide memo No. DHE-170008/34/2023-NPE dated 02.01.2024 will be followed in University Teaching Departments and USGS.

Information about Programmes in Physical Education

- 1. Games & Events recognized by the AIU will be accepted for admission to MPED.
- 2. A married girl is eligible for admission to B. Sc. Physical Health and Sports Education Programme but, it is also compulsory for her to sign an undertaking that she will discontinue the programme at once for at least one academic year, if she gets pregnant during the Programme(s) of study.
 - However, she can join back afresh from the beginning of the semester keeping in mind the guidelines pertaining to the maximum duration of the Programme(s).
- 3. Each student in department of Physical Education shall have to wear prescribed dress during the sports activities to be conducted in the morning and evening sessions. No student shall be allowed to attend the sports activities without proper dress.

Fees and Scholarship:-

- 1. Fee will be charged from the students semester/year-wise as per the nature of the Academic Programme and as per the fee structure given in the notification of each Academic Programme.
- 2. Department-wise Schedule will be notified by the Accounts Branch. Dues for the subsequent semester/years must be paid by the dates notified, shall be charged.
 - (i) A candidate whose result of the examination taken by him/her is notified as 'Later' may also be allowed to join the next higher class provisionally. In case he/she is ultimately declared as having failed, his/her provisional admission shall stand cancelled and he/she shall forthwith revert to the lower class. Fee paid by him/her for the higher class shall be adjusted against the lower class dues. No refund shall be admissible to the student who discontinues his/her studies. His/her attendance for the higher class will be counted for the lower class.
 - (ii) Students will deposit the fee on fixed date and time notified by Accounts Branch and will not be allowed to attend the class without depositing the fee. Students will deposit the fee online through Payment Gateway on fixed date and time.
- 3. Caution money/Security is refundable if application is received by 31st December of the year of the completion of Programme (application format as **Annexure-VI**).
- 4. The record of Admission fee/Examination fee slip be maintained/kept by the Department concerned only in the case of those who are entering into offline admissions. The Department concerned will mention fee receipt number on Financial Statement Performa while sending filled examination form to the Result Branch.
- 5. The fee shall be refunded/adjusted only in the first Semester of the Programme.
- 6. For the information of the old students who are enrolled in the SFS Programmes which have been discontinued, the fee of these programmes for remaining years will remain the same as it was mentioned in the concerned year HBI.

RULES FOR ADJUSTMENT/REFUND OF FEE:

1. If a candidate after having deposited fee for admission in one Programme joins another programme in another/same UTD in the same session, as mentioned below, and is permitted to withdraw his/her

candidature, fee/funds except admission fee already deposited by him/her for the programme from which he/she has withdrawn, shall be adjusted/refunded against the fee/funds of the programme he/she joins subject to the condition that the difference, if any, shall be paid by the candidate:

- i) From a Budgeted Programme to another Budgeted Programme;
- ii) From a budgeted Programme to a Self-financing Programme or vice- versa.
- iii) From a Self-financing Programme to another Self-financing Programme.
- **Note:** i) In case, the fee paid by the candidate is higher in one programme, then the same will be adjusted in the next semester fee during transfer from one programme to another.
 - ii) In case, the fee paid by the candidate is lower in one programme, then he/she has to pay difference of fee at the time of admission during transfer from one programme to another.
 - iii) In above both cases, the candidate has to pay Processing Fee @ Rs. 500/- for each transfer during admission.
 - iv) In Self-financing Programmes, adjustment/refund of fee will be allowed only if the seat so vacated is filled by the last date of admission subject to filling up of all the seats.
- 2. **For Budgeted Programme:** In case a candidate leaves the University after getting admission in a particular Programme, following conditions will apply for refund of fee:
 - (i) If a candidate leaves any programme upto September 30th 2024, the entire fee deposited by the candidate will be refunded.
 - (ii) If a candidate leaves any programme between 1st October 2024 to 31st December 2024, the fee deposited by the candidate will be refunded after deducting processing fee of Rs. 1000/-.

If a candidate leaves any programme after 31st December 2024, proportionate deduction of fee up to the month of his/her leaving will be made from the date of commencement of classes up to month of his/her leaving the programme, subject to minimum of Rs.1000/-. This is subject to the revision of the policy in this regard by UGC or the State Govt.

TUITION FEE CONCESSION:

(a) Full Tuition Fee Concessions may be given to deserving students by the Dean, USGS/Chairperson of the department concerned up to 10% or half fee concession to 20% of the total number of students on roll in each class/department. Application in this regard will be submitted to the department by upto 30th April, 2025. The departments will decide the cases by 31st May, 2025 and send the information to the Accounts Branch.

The Vice-Chancellor may, in deserving cases, on the recommendation of the Dean, USGS/Chairperson of the Department may grant additional fee concessions up to 10% provided that not more than one such additional fee concession shall be awarded in any class.

- (b) Tuition Fee concessions may be allowed to two or more children of the same parents at the following rates:
 - (i) The eldest to pay Full fee.
 - (ii) The younger or younger ones to pay half fee.

The Concessions will be allowed even if the elder brother/sister is studying in a University maintained Institution other than the one in which the younger brother(s)/sister(s) is/are studying.

- (c) 50% Tuition Fee concession to only girl / only two girl child(ren) (of parents without any male child) at U.G/Graduate level.
- (d) 1st, 2nd and 3rd position at the National Level competition organized by the Govt. agencies in similar events in sports and cultural sphere.

- (e) Development Fee concession may be allowed to anyone of the two brothers/sisters on admission to the same Programme in the University Teaching Department during the same session.
- (f) Fee concession to University employees and their dependents:
 - 50% concession of total fee (except examination fee and registration fee) to the University employee and their dependents (sons, daughters, brothers, sisters, spouse, who is/are not working and is/are fully dependent on him/her and living with him/her) may be allowed in part- time/regular programmes, self-financing programmes in the University Teaching Departments and the programmes in the University Centre for Distance Learning.
- (g) The children of serving military personnel up to the rank of an NCO or of military personnel killed or incapacitated wholly or partially during the war, shall be allowed Full Tution Fee Concession.
- (h) Blind students may on an application be granted Full Tution Fee Concession.
- (i) Further, Aid may be provided to the students as per Students' Aid Fund Clause No. 3.
- (j) Tuition fee concession may be granted at the time of admission to the deserving divyang students according to their percentage of disability. For example if a student has 50% disability, then 50% tuition fee concession will be granted and if a student has 100% disability then 100% tuition fee concession will be granted at the time of admission.
- (k) The fee concession to Divyang for Hand Book of Information Fee (Prospectus) will be at par with SC/BC candidates

Note: Free Education for Dependent Children of Leprosy Affected Persons (LAPs): No fee/dues will be charged from the dependent children of Leprosy Affected Persons and education in the University Teaching Departments/Institutes will be free for them.

FACILITIES AVAILABLE TO SC/DSC/BC CANDIDATES

- 1. For SC/DSC/BC candidates, the price of Handbook of Information/registration fees is 1/4th of the price fixed for open and other categories.
- 2. No fee will be charged by the USGS/college from the students belonging to the SC category as per instructions under the Post Matric Scholarship Scheme by the Director Higher Education, Haryana and the Director, Technical Education Haryana, for technical Programme(s) approved by AICTE.
- 3. For the Post Matric Scholarship Scheme of GOI for welfare of SC as per letter No.3/44-2012 Sch (2) dated 18.06.2013 of the Director General Higher Education, Haryana, Panchkula SC students whose family income from all sources is up to Rs. 2.50 lac per annum are eligible for benefits under the scheme. The benefits include enrollment/registration, tuition, games, Union, Library, Magazine, Medical Examination and such other fees compulsorily payable by the student to the institution or University/Board. Refundable deposit like caution money, security deposit are, however, excluded. For students admitted under this scheme, the application form has to be submitted by the students to the concerned Chairperson/Director of the Department/ Institute as per the date to be advertised/notified by the government.

Note: An income declaration will be furnished by the self-employed parents/guardian of SC candidates, stating definite income from all sources by way of an affidavit on non-judicial stamp paper. Employed parents/guardian are required to obtain income certificates from their employer and for any additional income from other sources, they would furnish declaration by way of an affidavit on non-judicial stamp paper. SC scholarships shall be awarded by the State Government to eligible SC students (as per eligibility guidelines) enrolled in a programme. Post Matric Scholarships are granted to SC/DSC/BC students under Govt. of India Scheme.

- 4. The USGS/Department will decide the eligibility for scholarship of such candidates on the basis of guidelines/norms given in the HBI.
- 5. Students who are eligible for Scheduled Caste and Backward Class Scholarship(s) as the case may be, may apply online on the dates which will be announced/published in the newspapers web portal of the State Govt./Funding Agencies

- 6. Students belonging to the SC/DSC/BC category who are eligible for Post Matric Scholarship Scheme should get their Saving Bank Account linked with Aadhaar Card to get transferred the funds in their respective bank accounts.
- 7. As per Memo No. Edu-1/2018/30135-160 dated 01.08.2018 and 3/31-2018(2) dated 22.04.2019. "All institutions are requested to verify the eligibility criteria of SC students for award of PMS-SC scholarship, and if found eligible, the date for depositing the fee for such SC students may be extended till scholarship amount is transferred to his/her account by the Govt. IF required, institution may take an assurance from such students that they will deposit the fee to institution within 10 days from the date they receive the same in their account"
- 8. Those SC/DSC students who are not eligible in the scholarship will pay fee/dues at par with General category students, along with the admission form. The SC/DSC students eligible for this scholarship will be themselves responsible for filling up Scholarship Forms as per schedule to be intimated by Registration & Scholarship Branch failing which they will have to deposit full fee within one month of the last date for filling scholarship forms. Late fee will be levied on such students. The eligibility for scholarship of such candidates will be decided by the Department, on the basis of guidelines/norms given in the HBI. Such students will submit their non-dues certificate before taking the final semester examination otherwise their DMC or Duplicate DMC or Provisional Degree or Duplicate Degree will not be issued. In case the SC/DSC candidates leave the programme before the completion of program his/her Migration Certificate will be withheld till he/she clears all the dues.
- 9. It will be the responsibility of the students to enclose necessary documents to claim fee concession and file application for scholarship.

Interpretation of Rules and Remedies and other Important Information

1. Nothing contained in the Handbook of Information would be construed to convey sanction or cited as an authority. Whenever there is inconsistency or contradiction, the University Ordinances and the Regulations contained in Calendars Vol. I, II, III of CDLU, Sirsa are to be referred.

2. The Remedies Provided in Respect of Admission Policy

In the event of any inconsistency with regard to the rules framed for admission etc. or in the event of any clarification with respect to the above said rules, the matter shall be referred to the Vice-Chancellor and the interpretation given by the Vice-Chancellor shall be final. The Vice-Chancellor is also competent to remove any inconsistency and to decide as to which provision shall take precedence over the other.

If any applicant or any other person is of the opinion that in his/her case, the rules framed for admission etc. have not been followed, he/she shall make an application outlining clearly the deviation in his/her opinion to the Vice-Chancellor. The Vice- Chancellor shall consider the application in the light of relevant rules and his decision in the matter shall be final.

3. DISCLAIMER

The statements made in the Handbook of Information and all other information contained herein, are believed to be correct at the time of publication. However, the competent authority reserves the right to make, at any time without notice, additions and alterations in the regulations, conditions governing admissions, the code of conduct of students, requirements for the degree or the diploma, fees and any other information or statement/rule contained in this Handbook. Competent authority may delete any Programme of Studies included in the Handbook of Information, at any time without notice or reduce or enhance the number of seats for reasons to be recorded in writing. No responsibility shall be accepted by the University for hardships or expenses incurred by the candidates or any other person for such changes, additions, omissions, or errors, no matter how they are caused.

- 4. If, at any stage, it is found that the candidate has supplied any incomplete or false or incorrect information in the application form, his/her candidature/enrolment for the programme shall be cancelled and he/she shall be liable for disciplinary action as per the University rules.
- 5. Admitted regular students will have to see the Notice Board for information pertinent to them. No separate information will be sent to them at their home address.





Steps after filling online Application







FEE

Fee will be charged from the students semester-wise. Fee will be deposited as per schedule of Accounts Branch displayed from time to time or as printed in the HBI. RESERVATION OF SEATS

- (A) 15% of the total seats shall be open and will be filled on All India basis including Haryana.
- (B) Remaining 85% seats are reserved for bona fide residents of Haryana and will be filled up as detailed below:

The seat matrix has been prepared on the basis of the reservation policy notified by the Govt. of Haryana vide Notification No. 22/10/2013 – IGSIII dated 28/2/2013 and 22/12/2019-1GS.III dated 25.02.2019, and instructions received from the State Govt. from time to time on the following basis:

In the event of quota reserved for Physically Handicapped remain unfilled due to non availability for suitable category of Handicapped Candidates, it may be offered to the Ex-Servicemen and their wards (1%) and the dependents of Freedom Fighters (1%).

Further, 3% reservation is also provided to Ex-serviceman/ Freedom Fighter and their dependents by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Caste and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided / Institutes located in Haryana. As far as Block allocation in Block-A and Block-B of Backward Classes category is concerned year wise rotational system will be adopted. For example if Block-A of Backward Classes are given seats in academic year 2014, the next Block i.e. (B) Block of Category of Backward Classes will be given seats in the next academic year 2015 and so on. Further, a roster register for reservation of seats for ex- servicemen/freedom fighter shall be maintained and carry forward all fractions till one seat is accumulated through different fractions over the years. As and when the total comes to one a seat will be provided. The Dean, USGS/Chairperson of the Department concerned shall maintain the record for the purpose.

Definitions of Disabilities:

Definitions of categories of disabilities are given below:

- (I) (a) Blindness: "Blindness" refers to a condition where a person suffers from any of the following conditions namely:
 - i) Total absence of sight; or
 - ii) Visual acuity not exceeding 6/60 or 20/200 (snellen chart) in the better eye with correcting lenses; or
 - (iii) Limitation of the field of vision subtending an angle of 20 degree or worse:

Low vision: 'Person with low vision' means a person with impairment of visual functioning even after treatment or standard refractive correction but who uses or is potentially capable of using vision for the planning or execution of a task with appropriate assistive device.

(II) Hearing Impairment: "Hearing Impairment" means loss of sixty decibels or more in the better ear

in the conversational range of frequencies.

- (III) (a) Locomotor disability: "Locomotor disability" means disability of the bones, joints or muscles leading to substantial restriction of the movement of the limbs or any form of cerebral palsy.
 - (b) Cerebral Palsy: "Cerebral Palsy" means a group of non-progressive conditions of a person characterized by abnormal motor control posture resulting from brain insult or injuries occurring in the pre-natal, pre-natal or infant period of development.
 - (c) All the cases of orthopedically handicapped persons would be covered under the category of "locomotor disability or cerebral palsy".

Guidelines for Reservation:

- 1. The Reservation of seats is as per the Reservation Policy of the Haryana Govt. and is subject to any change/amendment by the State govt. from time to time.
- 2. In case seats of DSC remains vacant, the same will be filled up from the SC candidates and vice versa. Similarly, if the reserved seat(s) of BC Block 'A' remain vacant these will be filled up from BC Block 'B' and vice versa. Further, if the reserved seats of EWS category remains vacant, then these will be filled up from HOGC/AI open as the case may be.
- 3. If a candidate of Haryana General, SC and BC also applies for Differently Abled/ESM/DFF category, he/she will be considered first for Haryana General, SC and BC category.
- 4. If the quota reserved for Differently Abled Persons candidates remains vacant due to non-availability of candidates, these seats will be given to ESM and their wards, dependents of Freedom Fighters and wards of Military Personnel who died in operation 'Vijay' on the basis of their merit.
- 5. Change of the category in the application form may be allowed if a candidate submits a valid proof to claim the category during the admission process.
- 6. In case the number of applications is/falls less than the number of sanctioned seats in any Programme, the vacant seats under reserved categories except SC will be filled as follows:
 - I. The seats remaining vacant in any other Reserved Category shall be filled from Haryana Open category, if the candidate belonging to the respective category is not available at the time of physical presence.
 - II. Further, in case, the seats remain vacant in Haryana Open category, the same will also be thrown open to All India Open category.
 - III. In case the number of applications received in any category is less than the number of sanctioned seats, all the vacant seats will be thrown open to as per the above two clauses.
 - IV. No SC/DSC seat will be converted into General category.
 - V. Roster System will not be maintained in case of admissions as per Haryana Govt. instructions.
 - VI. Further, in case the candidate of reserved category approaches the University that he could not present himself at the time of physical presence or one day before the close of admission in case of SC category, on sufficient ground and reserved seat has been filled up from the general category candidates, the proposal for additional seat(s) for that candidate will be put up by the concerned Department within 7 days. (For details refer to chapter Reservation).
 - VII. Candidates claiming reservation under Scheduled Caste, Backward Class (Block 'A' & 'B') and EWS (Govt. notification and certificate available at www.cdlu.ac.in) categories will submit the certificate as per Annexure-IX regarding income proof to decide creamy layer category,
- 7. Certificate from ward of Deceased/Disabled/Discharged Military/Para-Military personnel/Ex Servicemen or Ex-Personnel of Para-Military Forces Annexure-X must be enclosed with the admission form for taking the benefit of reservation.

The seats reserved for ESM category shall be offered in order of following priorities:

- a) Wards of Ex-servicemen died in action while in active service.
- b) Ex-serviceman himself.
- c) Wards of Ex-servicemen.
- d) Wards of Paramilitary Forces.

- 8. Only the candidates having permanent disability of not less than 40% (being otherwise fit for admission to the Programme(s)) will be considered for admission as Differently Abled. Disability certificate must be issued by the Chief Medical Officer of the concerned District. The Admission Committee can recommend for verification in case of any doubt to the concerned Chief Medical Officer. Differently abled candidates belonging to Haryana are required to submit the certificate as per Annexure-XI.
- 9. Children and Grand-Children of Freedom Fighters of Haryana are required to submit a certificate from the concerned Deputy Commissioner of the concerned District as per Annexure-XII.
- 10. ESM and their wards of Haryana are required to submit the certificate as per Annexure-XIII.
- 11. For horizontal reservation, ESM/DFF candidates of General, SC and BC category will also have to furnish ESM/DFF certificate as mentioned above.
- 12. In pursuance of the decision of Hon'ble Punjab & Haryana High Court, Chandigarh dated 11.01.2013 in the LPA 98/2013 (O&M) CWP No. 20359 of 2012, Sh. Ishwar Singh Vs KUK & Others, preference shall be given to ESM first before giving admission to wards against ESM reserved seats.
- 13. Eligible candidates whether from Haryana or from reserved categories will compete for seats allocated under All India Category.
- 14. A candidate, who applies for reserved category will be considered first in general category. In case, he/she does not get a seat of his/her choice in general category, then he/she will be considered for reserved category as applicable. The category of allotted seat may be higher than the actual category of the candidate.
- 15. If the number of seats in any particular category is not a round figure, 0.5 or above will be taken as one and less than 0.5 shall be ignored, except that in Physically Handicapped, Children & Grandchildren of Freedom Fighters and Ex-Servicemen and their Wards Categories, at least on candidate will be admitted from all the three categories in total, even if the share is less than 0.5 seats provided the number of sanctioned intake in the particular Programme(s) is 30 or above.
- 16. Candidates who have passed their qualifying examination from a university in the State of Haryana will be deemed to be Haryana residents and will not be required to submit certificates of bonafide residents of Haryana.
- 16. In case of tie for admission against sports seats, the applicant who has won position in higher tournament will be admitted.
- 17. A person belonging to the General Category married to a person belonging to the Scheduled Caste or Backward Classes, shall not be entitled to the benefit of reservation vide letter no. 22/76/2012-GSIII dated 22.03.2012 from Chief Secretary to Govt., Haryana.
- 18. The State Govt. of Haryana has decided to provide following concessions to the students belonging to Jammu & Kashmir for their admissions in the Colleges and Universities of Haryana.
 - (i) Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.
 - (ii) Increase in intake capacity upto 5% course-wise.
- 19. The Govt. Notification No. 22/12/2019-1GS.III dated 25.02.2019 for Economically Weaker Section (EWS) is attached.

Distributions of Seats:-

- 1. The Highest percentage 0.5 or above has been rounded subject to the fact that no increase to the total number of seats.
- 2. 30% seats shall be horizontal reserved for female candidates in each category for B. Sc. (Physical, Health and Sports Education).
- 3. **Further, 3% reservation is also provided to Ex-serviceman/Freedom Fighter and their dependents by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Caste and 1% from Backward Class Category for admission to the various educational institutions of the Govt. and Govt. aided/Institutes located in Haryana.
- 4. The reservation policy of State of Haryana applied.

Note:

- 1. The category-wise distribution of seats given above is according to the letter issued by the General Administration Department Haryana Government through Letter No. 22/10/2013-1GSIII dated 15.07.2014, 22/149/2015-IGSIII dated 01.04.2016 and 22/12/2019-1GS.III dated 25.02.2019.
- 2. The reservation in admission to the EWS candidates shall be given as per the Guidelines and Instructions supplied by the State Government i.e. 10% is to be given in both State Quota seats under State Policy and All India Quota seats under Central Government Policy separately (Annexure-XIV).
- 3. Two supernumerary seats will be created as a part of the Special Scholarship Scheme for Jammu & Kashmir for students from Jammu & Kashmir. (Reference: Chapter-2, point-17).
- 4. There shall be two additional seats in PG programmes (except the programmes where the seats have been approved by NCTE/BCI etc.) and five additional seats in UG Programmes (except the programmes where the seats have been approved by NCTE/BCI etc.) over and above the sanctioned seats for Outstanding Sports Persons. For admission against such seats, the candidate will be required to submit the grading certificate of sports issued by the Director of Sports and Youth Welfare, Govt. of Haryana, Chandigarh.

WEIGHTAGE(S)

Weightage marks are given to the students who have performed or participated in extracurricular activities. It creates a level of preference for the students who have been active in various development areas and/or causes for the society.

GUIDELINES FOR SPORTS WEIGHTAGE

Sports Certificate for weightage will only be considered, if the candidate produces the State/National position holder certificate from the respective State Government/Sports Department. In case, any state does not issue the Gradation Certificate, the following criteria will be adopted:

- a) In case of International/National participation or State Position Holder, a Certificate of authenticity will be required from the concerned National Federation/State Association.
- b) The game/even must be in the scheduled list of the Association of Indian University Sports Calendar.
- c) The tournament must be organized by a recognized Federation/Association duly affiliated with State Olympic Association/Indian Olympic Association and Ministry of Youth Affairs& Sports.

No weightage will be given for participating/winning positions in the sports and games organized by Nehru Yuva Kendra/CBSE National, Vidhya Bharti Nationals/Rural Tournaments/Panchayat Tournaments/Navodaya Nationals and participation in non-recognised tournaments/sports festivals.

Note:

- 1. The weightage section is important for the procedure of admission, as the fields will affect the weightage in the merit.
- 2. The above are the weightage questions, for each weightage, 5 percent marks shall be given which shall be added to the applicants total percentage and thus, a merit list will be prepared.
- 3. The weightage marks are given based on extra-curriculars performed or participated in by the Students.
- 4. The Students can avail a maximum of 10 percent for weightage.
- 5. Students from 10+2 commerce applying for B. Com will automatically get 5 % weightage added to their marks.
- 6. The applicant must have all the valid proofs and certificates to support their claims.

REGISTRATION

The concerned department will check the eligibility for admission at its own level. After the provisional admission, the Registration Branch will check the documents of all the admitted candidates for the purpose of registration. After the clearance of the eligibility, the Registration Branch will generate PRN (online) to the provisionally admitted candidates.

Note: i) The Candidates who have passed their qualifying examinations from a University/Board situated outside India, will have to deposit eligibility fee of Rs. 500/. They will have to deposit the documents including visa in the Registration Branch. Even provisional admission will not be allowed without the eligibility certificate.

ii) The eligibility fee @ Rs. 100/- from the students who have passed 10+2 from Haryana Board of School of Education, Bhiwani will not be charged.

Admission of students in no case should exceed the sanctioned strength of each Class/Course. The Dean, Academic Affairs will exercise control and supervise the admissions in the UTDs and in the Colleges respectively. A copy of the details showing sanctioned strength of each class/course/subject be prepared on prescribed format by the Principal/Chairperson, which is required to be sent along with the Registration Returns. Any delay in this regard will be viewed seriously. Admissions of students will be made only in such class/course/subject where the University has granted permission/affiliation.

Registration return will be filed with the name of the candidate, his/her father's & mother name and name of the college, both in English and Hindi. The department admission committee will be responsible for any error in the spellings and DMCs and Degrees will be based on them.

It may be ensured that the children of single parent are not denied admission in the College/Department on the plea that names of both the parents are not mentioned in the certificate of qualifying examination/admission form, if they are otherwise eligible/ subject to fulfillment of all other conditions of admission.

Principals/ Chairpersons must ensure that admissions are made subject to the fulfillment of the minimum eligibility conditions. Registration Returns of all such cases be sent on prescribed format and legible photocopies of the lower qualifying examination, duly attested by the Authority as detailed above, must accompany the same. For regularization of admission of such students, photocopies of the certificates, duly attested, of the examination Passed by the candidates(s) in supplementary as well as annual examination, be sent personally to Registration and Scholarship Branch immediately after the declaration of the result.

No regular student will be allowed to appear in the examination of the University until and unless his/her Registration Return has been sent to the University.

Registration Return (RR) will be submitted as per schedule of R&S.

The Registration Return/Continuation Return must reach the R&S Branch within 21 days of the last date of admission or within 15 days from the date of actual admission, whichever date is later, failing which a penalty will be charged for each day's delay subject to maximum of Rs. 20,000/-.

For PG

The Registration Return/Continuation Return must reach the R&S Branch within 21 days of the last date of admission or within 15 days after submission of final semester result (final year) as per HBI, whichever is later, failing which a penalty will be charged for each day's delay subject to maximum of Rs. 20,000/-.

MIGRATION RULES

A student from any other University recognized by CDLU, Sirsa or from a Board of Examination other than the Board of School Education, Haryana, shall be eligible for admission to the University only on production of the migration certificate (or transfer certificate if a Board does not issue the migration certificate) to show that the University or the Board has no objection to his/her joining this University and he/she will have to submit the same up to 30th November, 2024 without any late fee, failing which his/her candidature for the concerned examination shall stand suspended automatically, provided that the condition of production of the migration certificate shall not apply in the case of students passing their examination from Foreign University.

For the session **2024-25**, the last date for submission of Migration Certificate will be 30th November, 2024 without late fee and same will be accepted through concerned Chairperson/Principal even after 30th November, 2024 on payment of late fee upto the dates mentioned below:

Upto 30th November 2024 - Without late fee

Upto 31st December, 2024 - With late fee of Rs. 500/Upto 31st January, 2025 - With late fee of Rs. 1000/Upto 28th February, 2025 - With late fee of Rs. 2000/Till the declaration of result - With late fee of Rs. 2500/After the declaration of result - Rs. 5000/- (Maximum)

Note: The word examination in the above rules denotes the first Annual Examination or the second 'Semester Examination'.

ATTENDANCE/CLASS PARTICIPATION

- 1. In each programme, (except the programme approved by the BCI) every student will have to fulfill the condition of 75% minimum (theory & practical separately) of attendance as per the relevant is mandatory. (However, for the students in department of Law, the minimum attendance required is 70%).
- 2. Dean, USGS/Chairperson are authorized to condone 15% of the shortage by recording the reason. Further, the Vice Chancellor may further condone extra 10% of lecture shortage.
- 3. Ordinarily, a candidate who has not attended the required percentage of lectures/ practicals etc. in a particular subject, as prescribed shall not be eligible to appear in the concerned course/subject examination. If the Dean of USGS/Chairperson of the Department is not satisfied with the reasons for the shortage given by the student, it is not obligatory on his/her part to condone the shortage. The decision of the Dean of USGS/Chairperson of the Department shall be final.
- 4. Every student shall attend his classes on all working days unless he is granted leave of absence by the Dean, USGS/Chairperson.
- 5. If a student remains absent from his classes for a continuous period of seven working days each in one **subject/paper/Programme(s)** without any valid reason, medical or otherwise, his name shall be struck off from the rolls, irrespective of the fact that he/she has paid his/her dues.
- 6. However, the student may be re-admitted with the permission of the Dean, USGS/Chairperson of the Department concerned on payment of re-admission fee, as prescribed by the University from time to time in addition to arrears of fees, if any, provided that the Dean, USGS/Chairperson is satisfied that if re-admitted the student will not fall short of requisite percentage of lectures etc.
- 7. For allowing readmission by the Dean, USGS/Chairperson and Vice Chancellor time allowed will be 10 days in an academic year with readmission fee as follows:

 1^{st} instance Rs. 500/- + Rs. 10/- per day by Dean, USGS/Chairperson. 2^{nd} instance Rs. 1000/- + Rs. 20/- per day by Vice Chancellor

8. Distribution of Marks for attendance/class participation will be as under:

The students will abide by the attendance rules even if the classes are online.

INSTRUCTIONS TO CURB RAGGING

RULES FOR PROMOTION TO NEXT/HIGHER CLASS AND REAPPEAR/ IMPROVEMENT RULES


A. RULES FOR PROMOTION TO NEXT/HIGHER

All students of the programme will be provisionally admitted to next semester subject to deposit their fee and on rolls in the previous semester. For the BA LLB 5 year programme rules of the concerned regulatory body will be implemented.

B. IMPROVEMENT (as applicable in Ordinance)

After passing the examination, one chance in each semester may be given for improvement of marks in the programmes where provision of improvement exists. The syllabus will be the same as meant for the regular candidates of the semester(s) concerned.

Note: Time will be recorded up to the fraction of second. The qualifying time for men and women/candidates will be up to 30 seconds and 32 seconds, respectively.

IMPORTANT NOTES:

- 1. If a candidate commits two faults, he/she will not be allowed for re-test, whereas if only one fault is committed by the candidate, he/she will be given one more chance provided he/she completes the test within the prescribed time. Third chance will not be given under any circumstance.
- 2. Hurdles should be crossed without being knocked down. If a candidate leaves the test incomplete he/she will be disqualified and will not be given any chance. If any candidate falls or slips while performing the test he/she must complete the test and should not drop out in between and no extra chance would be given in such cases.

The above mentioned Civil Appeal No. 2718-2020 (Arising out of SLP No. 271420 of 2019) titled as Aryan Raj Vs. Chandigarh Administration and others from ble Supreme Court of India in its order dated July 08, 2020 observed that Scheduled Castes/Scheduled Tribes candidates are required to obtained 35% passing marks to pass in the aptitude test as against the requirement of 40% for general candidates. The relaxed criteria of 35% pass marks in aptitude test shall apply to the candidates with disabilities also for admission.

The Hon'ble Supreme Court Directed all States/UTs to take up the matter with Department of Education, Culture, General Administration and other concerned department on the following aspects:-

- Adopt a uniform qualifying criteria for Persons with Benchmark Disabilities included the Rights of Persons with Disabilities Act. 2016 Candidates of Scheduled Castes and Scheduled Tribes categories for admission to various higher educational courses
- Issue appropriate advisory to all Universities to develop courses suitable for Persons with Intellectual developmental mental disabilities for their educational empowerment.
- Consider increasing such number of seats in the discipline of painting and applied art.

All above mentioned Universities of Haryana State and Higher I ducation Department. Haryana need to send information regarding policies tollowed by them on above said matter.

In view of the compatibility committee remarks/footnote in its report, respective bodies i.e. AICTE, UGC and ICMR were specially invited in this meeting and the following were present during this meeting:

At the outset of discussion meeting, Sh. Devender Singh, ACSSDIT apprised that Haryana Board of School Education (HBSE), Bhiwani has recently provided equivalency to ITI courses (entry qualification 8th and 10th) with 10th or 10+2 for the purpose of vertical mobility into higher education as well as for employment opportunities. He also told that around 2321 ITI pass outs had appeared in the language exam taken by HBSE in July, 2019 & 63% have been got the equivalency certificate from HBSE and 92% trainees have opted the Hindi language. According to the granted HBSE equivalency to ITI pass outs, two separate issues are to be addressed as the following:

- (1) HBSE has provided an open equivalency to ITI pass outs which has opened the pathways for ITI pass-outs not only for Higher education but also for employment opportunities. As we aware that maximum of Group D and many of Group C posts in Haryana are being filled with the essential qualification as 10th and 10+2, a common rule/legislation is to be passed which is in process for all Departments/Boards/ Corporations for considering eligible to equivalent ITI Pass holders for all such posts which have essential qualification as 10th and 12th.
- There is a need in the amendment in the entry qualification in the Bachelor courses as 10+2 or its equivalent so as to open the pathway for ITI equivalency holders in B.A. , B. Com., B.Tech. etc.

In respect of the needed amendment in the entry qualification in the Bachelor courses as 10+2 or its equivalent so as to open the pathway for ITI equivalency holders in B.A., B. Com., B.Tech. etc. The following discussion and decision were held during the meeting: Action I:

Matter deliberated at a length and representative of UGC Sh. N. Gopu Kumar, Joint Secretary apprised that UGC has already mentioned the admission qualification for bachelor courses as 10+2 or its equivalent. Now further, State Statutory bodies like Higher Education/Technical Education Department has to issue directions for implementing the equivalency in the colleges of Haryana. Worthy Chief Secretary directed the Higher Education/Technical Education Department for writing to UGC, if needed, else direction be issued to all colleges of Haryana for granting admission to all ITI equivalent holders in B.A. & B.Com. & B. Voc. Courses. The process of issuing direction/ notification to colleges be completed by 31.10.19

Action II.

For availing admission to ITI pass outs in B. Tech./B.E. 1st year after clearing the common Engineering test.

Matter deliberated at a length and representative of AICTE Lt. Col. K. Bansal, Director, AICTE did not agree with the SDIT request and he clarified that only candidate with 10+2 with PCM can take admission in Engineering streams i.e. B. Tech./ B.E. Therefore, worthy CS has directed to re-examine the issue and

Subject: Bona fide Residents of Haryana – Guidelines regarding

Sir/Madam.

I am directed to invite your attention to Haryana Govt. letter on the subject noted above vide which the instruction were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institutions (including technical/medical institutions). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and other reported as AIR 1984.SC.1421, where in it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions. Henceforth the following categories of persons would be eligible for the grant of Resident certificate:

a. Candidates who have passes the examinations qualifying them for selection in an institution from a school/college in Haryana.

- b. Children/wards (if parents are not living) Dependent:
 - i. of the regular employees of Haryana State Posted in/outside Haryana State or working on deputation.
 - ii. of the regular employees of the statutory bodies/corporations established by or under an Act of the State of Haryana who are posted in Chandigarh or in/outside Haryana;
 - **iii**. of the regular employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government.
- c. Children/wards (if parents not living) dependents of persons who after retirement have permanently settled in Haryana and draw their pension from the treasuries situated in the State of Haryana.
- d. Children/Wards (if parents not living)/ dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a State other than Haryana or he has settled after retirement in or out side Haryana.
- e. Children/Wards (if parents not living)/dependents of persons who have permanently home in the Haryana and include persons who have been residing in Haryana for a period of less than 15 years or who have permanent home in Haryana but on account of their occupation they are living out side Haryana
- f. The wives of such persons who are bona fide resident of Haryana irrespective of the fact that they had belonged to any other State before marriage.
- g. Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/Guardians (if parents are not living) of persons belonging to any one of the above mentioned categories are:
 - i. Citizen of India;
 - ii. Produce an affidavit to the effect they or their children/ wards (if parents are not living)/dependents have not obtained the benefit of Resident in any other State.
- 2. All candidates claiming to be Bona fide residents of Haryana should produce a Haryana Resident Certificate singed by the District Magistrate / General Assistant of Deputy Commissioner of Sub-Divisional Officer (Civil) of the District/Sub-divisional to which the candidates belong. Residents Certificate in respect of elsewhere or in respect of the Children/Wards/dependents of Haryana Govt. Employee who are posted at Chandigarh, Delhi or elsewhere in respect Haryana in connection with affairs of Haryana Govt. or in respect of Children/Wards/dependents of the employees and retirees of the Statutory bodies/ Corporations of Haryana established by or under an Act of the State of Haryana or Central Act and located at Chandigarh, Haryana and outside Haryana, should be issued by their respective heads of Departments.
- 3. Candidates seeking admission in the Educational Institutions (including medical and technical institutions) located in Haryana may not be required to produce resident certificate, if they have passed the Examination from a School/College situated in Haryana. For this purpose a certificate of the Principal/Headmaster of the Institution shell, be competent to issue such certificate, which should be sufficient.
- 4. If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim is false, the student shall be removed from the institution, all fees and other dues paid up to the date of such removal shall be confiscated. The Principal may take such other action against the students and his /her parents/ Guardians as he may deem proper in the circumstances of any particular case.

(2) Save as provided in sub-Section (1), no person or authority shall confer, or grant, or hold himself or itself out as entitled to confer or grant, any degree......

Further, Section 23 of the UGC Act prohibits the use of the word 'University' by any institution other than a university established as stated above.

Subject: Regarding prescribing minimum eligibility qualification for the various courses.

Sir/Madam,

I am directed to invite your kind attention towards Government instructions No. 3870-WGI-ASOII-64/20069 dated 6th/9th October, 1964 whereby the candidates of Scheduled Castes and Scheduled Tribes provided 5% reduction in marks in the minimum eligibility qualification for admissions in various courses.

It has come to the notice of the Government that at present where a General Category candidate is required to have 50% marks in a prescribed qualification for admission in any course, as per the above instructions a reserve category candidate is required to have 45% marks giving him 5% reduction in the minimum qualification. Vide judgment of Hon'ble Supreme Court in Civil Appeal No. 7084/2011, it has been observed that the practice is wrong and the relaxation of 5% should be reduced from the minimum required marks on a general category candidate for e.g.:-

In a course, a general candidate requires to have 50% marks, than as per Govt. instructions by giving 5% relaxation the minimum eligibility marks for a reserved caste candidate should be calculated as under:-

Out of 100 Marks needs to less = 5

Out of 1 Marks needs to less = 5 / 100

Out of 50 Marks needs to less = 5 / 100 X 50 =2.50

This way minimum less marks where general category candidates are required to have 50% in a prescribed qualification, the total required marks for a reserved candidates will be 50 - 2.50 = 47.50 and not 45.

All concerned are requested to implement the instructions as per the above, procedure in the compliance of the judgment of Hon'ble Supreme Court passed in CWP No. 7084/2011.

GUIDELINES FOR SC/DSC SCHOLARSHIP

GOVT. OF INDIA POST MATRIC SCHOLARSHIP SCHEME FOR SCHEDULED CASTES STUDENTS

I. Conditions of Eligibility

- (i) The scholarships are open to nationals of India.
- (ii) Theses scholarships will be given for the study of recognized post-matriculation for post-secondary programmes pursued in recognized institution with the following exception. "Scholarships are not awarded for training programmes like aircraft maintenance Engineer's Programmes and Private pilot license Programmes. Programmes at Training ship dufferin (Now Rajendera) Programmes of training at the Military College, Dehradun, programmes at pre-examination Training Centers of all India State levels."
- (iii) Only those candidates who belong to Scheduled Caste so specified in relation to the State/Union Territory to which the applicant actually belongs i.e. permanently settled and who have passed the matriculation or Higher Secondary Education, will be eligible.
- (iv) Candidates who after passing one stage of education are studying in the same stage of education in different subject e.g. MSc after BA or B.Com. and after BA or MA in other subject will not be eligible.
- (v) Students who after having completed their educational career in one professional line. e.g. LLB. after B.T. /B.Ed. will not be eligible from the academic year 1980-81, studies in two professional programmes are allowed.
- (vi) Students studying in Class XI of the Higher Secondary School programmes of the XII class of the multipurpose high school will not be eligible for it being a continuous school programme. However, in cases where tenth Class examination of such programmes is treated as equivalent to Matriculation and students who after passing tenth class join other programmes, such students will be treated as post-matric students and will be eligible for the award of scholarships.
- (vii) Students pursuing Post graduate programmes in medicine will be eligible if they are not allowed to practice during the period of their programme.
- (viii) Students who after failing or passing the under graduate/Post- graduate examinations in Arts/ Science/Commerce join any recognized professional or Technical certificate/ diploma/ degree programmes will be awarded scholarships if otherwise eligible. No subsequent failure will be condoned except programmes in Group 'I'.
- (ix) Students who pursue their studies through correspondence programmes are also eligible. The term correspondence includes distant and continuing education.
- (x) Employed students whose income combined with the income of their parents/guardians does not exceed the maximum prescribed income ceiling are made eligible to post-matric scholarships to the extent of reimbursement of all compulsorily payable non-refundable fees.
- (xi) All children of the same parents/guardians will be entitled to receive benefits of the scheme.
- (xii) A scholarship holder under this scheme will not hold any other scholarship/stipend. If awarded any other scholarship/stipend, the student can exercise his/her and should inform the awarding authority through the Head of the Institution about the option made. No scholarship /stipend whichever is more beneficial to him/her and should inform the awarding authority through the head of the Institution about the option made. No scholarship will be paid to the students under this scheme form the dates he/she accepts another scholarship/stipend. The students can however, accept free lodging or a grant or adhoc monetary help form the state Government or any other source for the purchase of books, equipment or for meeting the expenses on board and lodging in addition to the scholarship amount paid under this scheme.
- (xiii) Scholarship holders who are receiving coaching in any of the pre-examination training centers with financial assistance form the Central Government/ State Government will not be eligible for stipend under the coaching schemes for the duration of the coaching programmer.

Note: It is mentioned under the item III (condition of eligibility) of these regulations that the Scholarship will be given for the study of all recognized post-matriculation or post-secondary programmes pursued in recognized institutions, the list of programmes grouped (1 to IV) is only illustrative and not exhaustive. The State Governments/ Union territory Administrations are, thus, themselves competent to decide the appropriate grouping of programmes at their level as advised vide this Ministry's letter No. 11017/13/88 Sch Cell, dated 3.8.1989.

II. OTHER CONDITIONS FOR THE AWARD

- 1. The scholarship is dependent on the satisfactory progress and conduct of the scholar. If it is reported by the head of the Institution at any time that a scholar has by reasons of his/her own act of default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without the permission of the authorities concerned etc, the authority sanctioning the scholarship may either cancel the scholarships or stop or withhold further payment for such period as it may think fit.
- 2. If a student is found to have obtained a scholarship by false statements, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of the concerned State Government. The student concerned will be blacklisted and debarred for scholarship in any scheme forever.
 - i) A scholarship awarded may be cancelled if the scholar changes the subject of the programme of study for which the scholarship was originally awarded or changes the Institution of study, without prior approval of the State Government. The Head of Institution shall report such cases to them and stop payment of the scholarship money. The amount already paid may also be recovered at the discretion of the State Government.
 - ii) A Scholar is liable to refund the scholarship amount at the discretion of the State Government, if during the programme of the year, the studies for which the scholarship has been awarded, is discontinued by him/her.
 - iii) The regulations can be changed at anytime at the discretion of the Government of India.

III. PROCEDURE FOR APPLYING

An application for scholarship should comprise:

- i. One copy of the application for scholarship in the prescribed form (separate application forms as have been prescribed for 'fresh' and renewal scholarship by concerned State/UTs)
- ii. One copy of the passport size photograph with signature of the student thereon (for fresh scholarship)
- iii. One attested copy of certificates, diploma, degree etc in respect of all examinations passed.
- iv. A certificate (in original) of caste duly signed by an authorized Revenue Officer not below the rank of Tehsildar.
- v. An income declaration by the self-employed parents/guardians, stating definite income from all sources by way of an affidavit on non-judicial stamp paper. Employed parents/guardians are required to obtain income certificate from their employer and for any additional income from other sources. They would furnish declaration by way of an affidavit on non-judicial stamp paper. Scholarship will be paid to the student whose parents/guardians income from all sources does not exceed Rs. 2,50,000/- per annum.
- vi. A receipt in acknowledgement of the scholarship in previous year on the form attached to the application only duly counter-signed by the Head of the institution concerned, it the application was in receipt of a scholarship under this scheme in the preceding year.
- vii. Application complete in all respects shall be submitted to the Head of the Institution, being attended or last attended by the candidates and shall be addressed to an officer specified for this purpose to the Government of State/union territory to which the student belongs, in accordance with the instructions issued by them from time to time.
 - (For detail of the scheme of the above Scholarship may be consulted from Registration & Scholarship Branch.)

Note: The BC students may also apply for Post Matric Scholarship whose parents' annual income from all sources is less than **Rs. 2,50,000/-** per annum. They will be paid maintenance allowance only.

Reservation for Economically Weaker Sections in Direct recruitment in Civil posts and services as well as in admissions in Government/Government Aided Educational Institutions in the State of Haryana.

I am directed to inform that Government of India has notified "THE CONSTITUTION (ONE HUNDRED AND THIRD AMENDMENT) ACT, 2019" on 12th January, 2019 amending Article 15 & 16, which now read as under:-

Amendment of article 15

In Article 15 of the Constitution, after clause (5), the following clause shall be inserted, namely:—

- '(6) Nothing in this article or sub-clause (g) of clause (1) of article 19 or clause (2) of article 29 shall prevent the State from making,—
- (a) any special provision for the advancement of any economically weaker sections of citizens other than the classes mentioned in clauses (4) and (5); and
- (b) any special provision for the advancement of any economically weaker sections of citizens other than the classes mentioned in clauses (4) and (5) in so far as such special provisions relate to their admission to educational institutions including private educational institutions, whether aided or unaided by the State, other than the minority educational institutions referred to in clause (1) of article 30, which in the case of reservation would be in addition to the existing reservations and subject to a maximum of ten per cent. of the total seats in each category.

Explanation— For the purposes of this article and article 16, "economically weaker sections" shall be such as may be notified by the State from time to time on the basis of family income and other indicators of economic disadvantage.'



Amendment of article 16

In Article 16 of the Constitution, after clause (5), the following clause shall be inserted, namely:—

"(6) Nothing in this article shall prevent the State from making any provision for the reservation of appointments or posts in favour of any economically weaker sections of citizens other than the classes mentioned in clause (4), in addition to the existing reservation and subject to a maximum of ten per cent. of the posts in each category".

In the wake of above enabling provisions, State Government has considered the matter and decided to provide benefits of reservation on a preferential basis in Civil Posts in all its Departments/ Boards/ Corporations/Local Bodies and in Admissions to Government/Government Aided Educational Institutions to those Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservation for the Scheduled Castes, Backward Classes (Block-A) and Backward Classes (Block-B).

QUANTUM OF RESERVATION:

The persons belonging to EWSs who are not covered under the existing scheme of reservation for Scheduled Castes, Backward Classes (Block-A) and Backward Classes (Block-B) shall get 10% reservation in direct recruitment to Group A,B,C and D posts in the Departments/Boards/Corporations/Local Bodies of Government of Haryana and also in admission to Government/Government Aided Educational Institutions in the State of Haryana.

3. EFFECTING RESERVATION - ROSTER POINT:

- 3.1 Direct recruitment in case of Group- A & B
 Roster point No. 11-20-30-40-51-60-70-80-90 and 99
- 3.2 Direct recruitment in case of Group- C & D
 Roster point No. 4-14-24-34-43-53-66-76-83 and 94
- 3.3 Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and will be filled from unreserved category.
- 3.4 Persons belonging to EWS selected against the quota for persons with benchmark disabilities/ex-servicemen shall be placed against the roster points earmarked for EWS.

4. CRITERIA OF INCOME & ASSETS:

- 4.1 Persons who are not covered under the exiting scheme of reservation for Scheduled Caste, Backward Classes (Block-A) and Backward Classes (Block-B) and whose family has gross annual income below Rs 6.00 lakh (Rupees six lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application.
- 4.2 Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-
 - 5 acres of agricultural land and above;
 - Residential flat of 1000 sq ft. and above;
 - Residential plot of 100 sq. yards and above in notified municipalities;
 - Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
 - v. Total immovable assets owned are valued at Rs. One Crore
- 4.3 The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- 4.4 The term "Family" for this purpose will include the person who applies for benefit of reservation, his/her parents, spouse as well as children and siblings below the age of 18 years.

5. INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:

- 5.1 The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Competent Authority for EWS Income and Asset Certificate shall be Tehsildar of the area where the applicant normally resides.
- 5.2 The prescribed format for EWS Income and Asset Certificate shall be as provided at Annexure-I.
- 5.3 The Officer who issues the certificate would do the same after carefully verifying all relevant documents following due process as prescribed by the State.
- 5.4 The crucial date for submitting Income and Asset Certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise.



5.5 The appointing authorities should, in the offer of appointment to the candidates claiming to be belonging to EWS, include the following clause:-

"The appointment is provisional and is subject to the Income and asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate."

The appointing authority should verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority.

5.6 Instructions referred to above should be strictly followed so that it may not be possible for an unscrupulous person to secure employment on the basis of a false claim and if any person gets an appointment on the basis of such false claim, her/his services shall be terminated and penal action shall also be invoked.

6. ADJUSTMENT AGAINST UNRESERVED VACANCIES:

A person belonging to EWS cannot be denied the right to compete for appointment against an unreserved vacancy. Persons belonging to EWS who are selected on the basis of merit and not on account of reservation are not to be counted towards the quota meant for reservation.

 The above scheme of reservation will be effective in respect of all direct recruitment vacancies to be notified on or after 01.02.2019.

- In this connection, representations have been received from Kashmiri Pandits (Non-Migrants) living in the Kashmir Valley to extend the existing concessions being provided to Kashmiri Migrants for them also.
- 3. The matter has been considered in this Department in consultation with Ministry of Home Affairs and State Government of Jammu & Kashmir. Now, it has been decided to allow the following concessions to the wards of Kashmiri Migrants as well as Kashmiri Pandits/ Kashmiri Hindu Families (Non-Migrants) who are living in the Kashmir Valley, in the matter of their admission in the educational institutions in other parts of the country from the academic year 2020-21 and onwards till further orders:
- Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.

(ii) Increase in intake capacity upto 5% course-wise.

- (iii) Reservation of at least one seat in merit quota in technical/professional institutions.
- (iv) Waiving off domicile requirements for Kashmiri Migrants only. Kashmiri Pandits/Kashmiri Hindu Families (Non-Migrants) living in the Kashmiri Valley need domicile certificate.

This issues with the approval of Hon'ble HRM.
