At the outset chairperson welcomed the members present in the meeting. The following decisions were taken in the meeting:


1. Discussed and recommended to change the nomenclature of M. A. Geography to M. Sc. Geography. Further, it was resolved to forward it to Academic Council for approval.

Further, it was resolved to communicate it to D. G. H. E. through Dean Academic Affairs, CDLU, Sirsa. The matter of LOCF w.r.t. B. A. (Hons.) in Economics and Under Graduate programmes was postponed as per the directions circulated by the Dean Academic Affairs, CDLU, Sirsa.


