With late fee of Rs.1500/-	15 days before the commencement of exam.  Further, the students who submits duly filled examination form 02 days before the commencement of examinations shall be allowed with the permission of the Hon'ble Vice-Chancellor with the penalty of the Rs. 100/- per day, in addition to late fee of Rs. 1500/- plus usual exam fee. Therefore, Examination form/List of the students shall not be entertained.

**Note:** The following instructions need to be issued along with the above schedule of exam:

1. The Chairpersons of respective Departments are requested to notify the schedule amongst the students of their Departments and send the list of students and detail of fees in one lot to the concerned branch.
2. In case of late declaration of result for no fault of the candidate(s), no late fee shall be charged upto 15 days from the date of declaration of result. Therefore, late fee will charge as per examination schedule.
3. If the number of teaching days falls less than 180 days in the academic session 2021-22 due to some unforeseen reasons, it shall be responsibility of each teacher to complete the syllabus by taking extra classes.
4. In the event, if holiday(s)/declared holiday(s), the next working will be deemed to be the last date.
5. The Chairpersons concerned may submit examination fee alongwith list of the student's/examination forms in the Result Branch within 03 (three working days) after last date as mentioned in the schedule.
