"A Late fee of Rs. 1,500/- + usual Exam Fee will be charged from the students who submits duly filled Examination Form 15 days before of the commencement of the examinations. The students who submits duly filled Examination Form 02 days before the commencement of examination shall be allowed with the permission of the Hon'ble Vice-Chancellor with the penalty of Rs. 100/- per day, in addition to late fee Rs.1,500/- + usual Exam Fee. Thereafter, Examination Form/List of the students may not be entertained".
