IMPROVEMENT:

After passing the examination, one chance in each semester may be given for improvement of marks in the programmes where provision of improvement exists. The syllabus will be the same as meant for the regular candidates of the semester(s) concerned.

Note: The following instructions:

- 1. Dean/Chairpersons/Principals of respective USGS/Departments/Colleges may be requested to notify the schedule among the students of their USGS/Departments/Colleges and send the List of Students, financial statements and fees of all the students in *one lot* to the concerned Branch, within 03 days after last date.
- 2. In case of late declaration of result for no fault of the candidate(s), no late fee shall be charged up to 15 days from the date of declaration of result. Thereafter, late fee will be charged as mentioned at Sr. No. 5.

- 3. If the number of teaching days falls less than 180 days (90 days in each semester) in the academic session 2023-2024 due to some unforeseen reasons, it would be the responsibility of each Department/Institute/College to complete the syllabus by taking extra classes.
- 4. In the event, if holiday(s)/declared holiday(s), the next working day will be deemed to be the last date.
- *As per decision of the Academic Council in its meeting held on 05.05.2015, it is hereby notified for information to all concerned that Examination Form(s)/List of the students of Fresh/Re-appear/improvement cases of the University students, after the stipulated-time-period, as notified by the Conduct Branch for relevant University examinations, will be accepted as under:

"A Late fee of Rs. 1500/- + usual Exam Fee will be charged from the students who submits duly filled Examination Form 15 days before of the commencement of the examinations. The students who submit duly filled Examination Form 02 days before the commencement of examination shall be allowed with the permission of the Hon'ble Vice-Chancellor with the penalty of Rs. 100/- per day, in addition to late fee Rs. 1500/- + usual Exam Fee. Thereafter, Examination Form/List of the students may not be entertained".
