MINUTES OF MEETING

The meeting of the Committee constituted by the Vice-Chancellor comprising the following to prepare the bifurcation of seats (Seat Matrix), Admission Schedule/Admission Notice for the admissions in Ph.D. programme were held on 29.08.2024 & 30.08.2024 in the office of Dean Academic Affairs, Chaudhary Devi Lal University, Sirsa.

The committee discussed the matter related to distribution of seats (Seat Matrix), Admission Schedule, Admission Notice for admissions in Ph.D. programme for the Session 2024-25 and recommended the following:

1. The Committee prepared the seat matrix according to Haryana State Reservation Policy (**Annexure-I**) and fraction of the session 2022-23 was carried forward as per Ph.D. ordinance.
2. The committee prepared the admission schedule and admission notice for admission in Ph.D. programme for the session 2024-25 (**Annexure-II & V**).
3. The seats advertised for a particular category may be filled as per advertisement i.e. AI/HOGC/BC-A/BC-B/EWS/SC/DSC/DAP. Conversion of seats will be as per State Reservation Policy of Haryana.
4. NET percentile score is not available at this time and Committee unanimously recommends that Ph.D. admission for the Session 2024-25 may be made on the basis of Ph.D. Ordinance 2022-23.
5. The Department of Botany, Chemistry, English & Foreign Languages, Mathematics, Physical Education, Zoology and Political Science has not offered any Ph.D. seats for admission in session 2024-25 as these departments have admitted JRF candidates from the session 2022-23 onwards. The seat bifurcation/distribution/fraction and reservation policy should be ascertained before admitting any candidate in above mentioned departments.
6. The departments will provide the Research Methodology syllabus for entrance examination as mentioned in Ph.D. ordinance to be conducted for admission to Ph.D. programme latest by 15.09.2024 to the Controller of Examinations directly.
7. The admissions should be made as per Ph.D. Ordinance 2022-23 for Foreign Nationals also.
