The members perused the data collected and compiled by the office of IQAC and approved the AQAR for the session 2022-23 for submission on the NAAC portal. It was further resolved that keeping in view the last date i.e. 29th Feb. 2024 for submission of AQAR on NAAC portal, the AQAR may be approved u/s 11(6) of the University Act so that the AQAR for the session 2022-23 may be uploaded on the NAAC portal. Further, all the points of AQAR have been discussed by the IQAC and the following suggestions were recommended by the IQAC and committee Chairman and members:

1. That the mechanism may be made for keeping the record of point number 1.3.4, 3.1.3, 3.3.3, 3.4.2, 3.4.3, 3.4.5, 3.4.6, 3.6.2, 3.6.3, 5.1.2, 5.1.1, 5.2.1, 5.2.2, 5.2.3, 5.3.1, 6.3.3 and 6.3.4.
2. That at least two meetings of IQAC should be convened in each academic session.
3. That the university should increase the number of smart class rooms in the UTDs and USGS.
4. That the Chairperson, Board of Studies will obtain the suggestions from the alumni entrepreneurs while framing/revising the curriculum.

5. That training programs should be conducted to increase the knowledge and efficiency of teaching and non-teaching staff.
6. UCOPE will organize a specialized training for the Branch Heads and the Branch Heads will organize trainings for the employees deputed in their branches. Certificate will be issued to all the participants and resource persons.
7. Policy should be framed for teachers who received awards, recognition, fellowships at state, National, International level from Government/Govt. recognized bodies during the year.
8. The IQAC members pointed out that financial support for attending the conferences is very less and it should be increased maximum up to Rs. 50,000/-
